### **HOUSE BILL 171** 1 Article 10 - Legal Officials 2 39A. 3 (a) For the limited purpose of obtaining documents to further an ongoing 4 criminal investigation, the State's Attorney may issue, within the county served by the State's Attorney, a subpoena to a person to require the production of telephone, 6 business, governmental, or corporate records or documents. 7 Such subpoena may be served in the same manner as if issued from a (b) (1)8 circuit court. 9 If any person fails to obey such subpoena lawfully served, the State's 10 Attorney may immediately report the disobedience and provide a copy of the 11 subpoena and proof of service to the circuit court of the county in which the State's 12 Attorney serves under § 34 of this article. 13 The court shall conduct a hearing and may grant appropriate relief 14 after providing the person who allegedly failed to comply with a subpoena an 15 opportunity to be heard and be represented by counsel.
