# 2 Sentencing - Murder of Driver-for-Hire

- 3 FOR the purpose of adding to the list of aggravating circumstances to the crime of
- 4 murder in the first degree; providing that it is an aggravating circumstance if
- 5 the victim was a licensed driver of a for-hire vehicle who was murdered while
- 6 performing the duties of a driver-for-hire; and generally relating to sentencing
- 7 for first degree murder.

- 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 19 MARYLAND, That the Laws of Maryland read as follows:

## 20 Article 27 - Crimes and Punishments

- 23 first consider whether, beyond a reasonable doubt, any of the following aggravating

1 (2) The defendant committed the murder at a time when he was confined 2 in any correctional institution; 3 The defendant committed the murder in furtherance of an escape or 4 an attempt to escape from or evade the lawful custody, arrest, or detention of or by an 5 officer or guard of a correctional institution or by a law enforcement officer; 6 The victim was taken or attempted to be taken in the course of a 7 kidnapping or abduction or an attempt to kidnap or abduct; 8 (5) The victim was a child abducted in violation of § 2 of this article; 9 (6)The defendant committed the murder pursuant to an agreement or 10 contract for remuneration or the promise of remuneration to commit the murder; 11 The defendant engaged or employed another person to commit the 12 murder and the murder was committed pursuant to an agreement or contract for 13 remuneration or the promise of remuneration; 14 At the time of the murder, the defendant was under sentence of death (8)15 or imprisonment for life; The defendant committed more than one offense of murder in the 16 17 first degree arising out of the same incident; [or] 18 (10)The defendant committed the murder while committing or 19 attempting to commit a carjacking, armed carjacking, robbery, arson in the first 20 degree, rape or sexual offense in the first degree; OR THE VICTIM WAS A LICENSED DRIVER OF A FOR-HIRE VEHICLE WHO 21 (11)22 WAS MURDERED WHILE PERFORMING THE DUTIES OF A DRIVER-FOR-HIRE. 23 If the court or jury does not find, beyond a reasonable doubt, that one or 24 more of these aggravating circumstances exist, it shall state that conclusion in writing, and a sentence of death may not be imposed. SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 26 27 October 1, 1998.
