- 3 FOR the purpose of requiring the Motor Vehicle Administration to refund a certain
- 4 portion of vehicle registration fees on surrender of registration cards and
- 5 registration plates; specifying the manner in which the refund is to be
- 6 calculated; restricting refunds under specified circumstances; repealing a
- 7 provision authorizing refunds under limited circumstances; and generally
- 8 relating to vehicle registration fee refunds upon surrender of registrations.

- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, That the Laws of Maryland read as follows:

16 Article - Transportation

- 18 (a) Notwithstanding any other provision of this subtitle, the Administration
- 19 may adopt a system of multiyear registration.
- 20 (b) Vehicle registration plates or validation tabs shall be issued and displayed
- 21 in accordance with a schedule established by the Administrator.
- 22 (c) The fee for a multiyear registration is the same as the annual registration
- 23 fee established under this title multiplied by the number of years for which the
- 24 registration is issued.
- 25 (d) [The Administration shall refund the registration fees upon surrender of
- 26 the registration card and registration plates if the return is made before the
- 27 beginning of any 12-month registration year for which the application for refund is
- 28 made.]

- 1 (1) SUBJECT TO PARAGRAPH (3) OF THIS SUBSECTION, ON SURRENDER
- 2 OF THE REGISTRATION CARD AND REGISTRATION PLATES, THE ADMINISTRATION
- 3 SHALL PRORATE THE FEE PAID FOR THE APPLICABLE REGISTRATION PERIOD ON A
- 4 MONTHLY BASIS IN ACCORDANCE WITH PARAGRAPH (2) OF THIS SUBSECTION AND
- 5 REFUND THE BALANCE FOR THE REMAINING REGISTRATION PERIOD.
- 6 (2) THE REFUND UNDER PARAGRAPH (1) OF THIS SUBSECTION SHALL BE
- 7 CALCULATED BY MULTIPLYING ONE-TWELFTH OF THE APPLICABLE ANNUAL FEE BY
- 8 THE NUMBER OF FULL MONTHS REMAINING IN THE REGISTRATION PERIOD AND
- 9 ROUNDING THE PRODUCT TO THE NEAREST DOLLAR AMOUNT.
- 10 (3) IF A REQUEST FOR A REFUND IS SUBMITTED FOR A REGISTRATION
- 11 THAT IS SUSPENDED, THE ADMINISTRATION MAY NOT PROCESS THE REQUEST UNTIL
- 12 THE SUSPENSION IS WITHDRAWN.
- 13 (e) The Administration may adopt regulations to carry out the provisions of 14 this section.
