16 Preamble

- 17 WHEREAS, There is a need for an effective comprehensive urban community
- 18 college in Baltimore City offering educational programs that will stimulate the
- 19 participation of individuals, be responsive to the needs of the community, and prepare
- 20 individuals to be qualified participants in the region's economy; and
- 21 WHEREAS, The Maryland General Assembly in 1990 made a commitment to
- 22 provide an adequate level of funding to Baltimore City Community College to correct
- 23 a history of underfunding at the college; and

- WHEREAS, Baltimore City Community College is the only Maryland public
- 2 community college not affected by the funding mechanism enacted for the other
- 3 seventeen community colleges in 1996; now, therefore,
- 4 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 5 MARYLAND, That the Laws of Maryland read as follows:
- 6 Article Education
- 7 16-502.
- 8 (a) In this subtitle the following words have the meanings indicated.
- 9 (b) "Board of Trustees" means the Board of Trustees of Baltimore City
- 10 Community College.
- 11 (c) "College" means Baltimore City Community College, formerly known as
- 12 the New Community College of Baltimore.
- 13 (d) "Commission" means the Maryland Higher Education Commission.
- 14 (E) "FULL-TIME EQUIVALENT STUDENT" MEANS THE QUOTIENT OF THE
- 15 NUMBER OF STUDENT CREDIT HOURS PRODUCED IN THE FISCAL YEAR 2 YEARS
- 16 PRIOR TO THE FISCAL YEAR FOR WHICH THE STATE APPROPRIATION IS CALCULATED
- 17 DIVIDED BY 30, AS CERTIFIED BY THE MARYLAND HIGHER EDUCATION COMMISSION.
- [(e)] (F) "Officer" means the president and the vice presidents of the College
- 19 and other officers as shall be appointed by the Board of Trustees.
- 20 [(f)] (G) "Secretary" means the Secretary of Higher Education.
- 21 (H) "STATE APPROPRIATION" MEANS THE AMOUNT OF MONEY FOR
- 22 BALTIMORE CITY COMMUNITY COLLEGE OPERATING FUNDS TO BE PROVIDED EACH
- 23 FISCAL YEAR TO THE BOARD OF TRUSTEES BY THE STATE.
- 24 (I) "STUDENT CREDIT HOURS" MEANS STUDENT CREDIT HOURS OR CONTACT
- 25 HOURS WHICH ARE ELIGIBLE, UNDER THE REGULATIONS ISSUED BY THE MARYLAND
- 26 HIGHER EDUCATION COMMISSION, FOR INCLUSION IN STATE FUNDING
- 27 CALCULATIONS.

- 29 (A) THE TOTAL STATE OPERATING FUND PER FULL-TIME EQUIVALENT
- 30 STUDENT APPROPRIATED TO BALTIMORE CITY COMMUNITY COLLEGE FOR EACH
- 31 FISCAL YEAR AS REQUESTED BY THE GOVERNOR SHALL BE:
- 32 (1) IN FISCAL YEAR 1999, NOT LESS THAN AN AMOUNT EQUAL TO 60% OF
- 33 THE STATE'S GENERAL FUND APPROPRIATION PER FULL-TIME EQUIVALENT
- 34 STUDENT TO THE 4-YEAR PUBLIC INSTITUTIONS OF HIGHER EDUCATION IN THE
- 35 STATE AS DESIGNATED BY THE COMMISSION FOR THE PURPOSE OF ADMINISTERING

- 1 THE JOSEPH A. SELLINGER PROGRAM UNDER TITLE 17 OF THIS ARTICLE IN THE

- 3 (2) IN FISCAL YEAR 2000, NOT LESS THAN AN AMOUNT EQUAL TO 63% OF
- 4 THE STATE'S GENERAL FUND APPROPRIATION PER FULL-TIME EQUIVALENT
- 5 STUDENT TO THE 4-YEAR PUBLIC INSTITUTIONS OF HIGHER EDUCATION IN THE
- 6 STATE AS DESIGNATED BY THE COMMISSION FOR THE PURPOSE OF ADMINISTERING
- 7 THE JOSEPH A. SELLINGER PROGRAM UNDER TITLE 17 OF THIS ARTICLE IN THE
- 8 PREVIOUS FISCAL YEAR; AND
- 9 (3) IN FISCAL YEAR 2001 AND EACH FISCAL YEAR THEREAFTER, NOT
- 10 LESS THAN AN AMOUNT EQUAL TO 66% OF THE STATE'S GENERAL FUND
- 11 APPROPRIATION PER FULL-TIME EQUIVALENT STUDENT TO THE 4-YEAR PUBLIC
- 12 INSTITUTIONS OF HIGHER EDUCATION IN THE STATE AS DESIGNATED BY THE
- 13 COMMISSION FOR THE PURPOSE OF ADMINISTERING THE JOSEPH A. SELLINGER
- 14 PROGRAM UNDER TITLE 17 OF THIS ARTICLE IN THE PREVIOUS FISCAL YEAR.
- 15 (B) NOTWITHSTANDING SUBSECTION (A) OF THIS SECTION, THE STATE
- 16 APPROPRIATION TO BALTIMORE CITY COMMUNITY COLLEGE REQUESTED BY THE
- 17 GOVERNOR MAY NOT BE LESS THAN THE STATE APPROPRIATION TO THE COLLEGE
- 18 REQUESTED BY THE GOVERNOR IN THE PREVIOUS FISCAL YEAR.
- 19 (C) THE STATE SHALL DISTRIBUTE THE STATE APPROPRIATION UNDER THIS
- 20 SUBSECTION TO THE BOARD OF TRUSTEES OF BALTIMORE CITY COMMUNITY
- 21 COLLEGE ON A QUARTERLY BASIS.
- 22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take
- 23 effect July 1, 1998.
