**Juvenile Justice Act of 1998**

3 FOR the purpose of ~~altering the jurisdiction of the juvenile court; altering the~~  
4 ~~jurisdiction of the juvenile court; establishing certain exceptions;~~ modifying  
5 juvenile confidentiality requirements pertaining to certain records; permitting  
6 law enforcement agencies to include certain juvenile record information in law  
7 enforcement computer information systems for certain purposes; requiring the  
8 juvenile court to report certain juvenile record information to the Criminal  
9 Justice Information System Central Repository; establishing a Commission on  
10 Juvenile Justice Jurisdiction; establishing the duties and responsibilities,  
11 membership, reporting requirements, and the termination of the Commission;

25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

29 (a) If the court obtains jurisdiction over a child, that jurisdiction continues  
30 until that person reaches 21 years of age unless terminated sooner.

31 (b) This section does not affect the jurisdiction of other courts over a person  
32 who commits an offense after he reaches the age of 18.

33 (c) Unless otherwise ordered by the court, the court's jurisdiction is  
34 terminated over a person who has reached 18 years of age when he is convicted of a

20 (a) (1) A police record concerning a child is confidential and shall be  
 21 maintained separate from those of adults. Its contents may not be divulged, by  
 22 subpoena or otherwise, except by order of the court upon good cause shown or as  
 23 otherwise provided in § 7-303 of the Education Article.

24 (2) This subsection does not prohibit:

25 (I) [access] ACCESS to and confidential use of the record by the  
 26 Department of Juvenile Justice or in the investigation and prosecution of the child by  
 27 any law enforcement agency; OR

28 (II) A LAW ENFORCEMENT AGENCY OF THE STATE OR OF A  
 29 POLITICAL SUBDIVISION OF THE STATE OR THE CRIMINAL JUSTICE INFORMATION  
 30 SYSTEM FROM INCLUDING, IN THE LAW ENFORCEMENT COMPUTER INFORMATION  
 31 SYSTEM, INFORMATION ABOUT AN OUTSTANDING JUVENILE COURT ORDERED WRIT  
 32 OF ATTACHMENT, FOR THE SOLE PURPOSE OF APPREHENDING A CHILD NAMED IN  
 33 THE WRIT.

34 (b) (1) A court record pertaining to a child is confidential and its contents  
 35 may not be divulged, by subpoena or otherwise, except by order of the court upon good  
 36 cause shown or as provided in § 7-303 of the Education Article.

1           (2)       This subsection does not prohibit access to and the use of the court  
2 record or fingerprints of a child described under the Criminal Justice Information  
3 System subtitle of Article 27 of the Code in a proceeding in the court involving the  
4 child, by personnel of the court, the State's Attorney, counsel for the child, a  
5 court-appointed special advocate for the child, or authorized personnel of the  
6 Department of Juvenile Justice, or, in a proceeding involving a child alleged to be in  
7 need of assistance, by authorized personnel of the Social Services Administration and  
8 local departments of social services of the Department of Human Resources in order  
9 to conduct a child abuse or neglect investigation or to comply with requirements  
10 imposed under Title IV-E of the Social Security Act.

11           (3)       Information obtained from a juvenile court record by authorized  
12 personnel of the Department of Human Resources under paragraph (2) of this  
13 subsection is subject to the provisions of Article 88A, § 6 of the Code.

14           (4)       (i)       Except as provided in subparagraph (ii) of this paragraph, this  
15 subsection does not prohibit access to and confidential use of the court record or  
16 fingerprints of a child described under the Criminal Justice Information System  
17 subtitle of Article 27 of the Code in an investigation and prosecution by a law  
18 enforcement agency.

19                       (ii)       The court record or fingerprints of a child described under  
20 Article 27, §§ 747(a)(21) AND (22) and 747A of the Code may not be disclosed to:

- 21                                       1.       A federal criminal justice agency or information center; or
- 22                                       2.       Any law enforcement agency other than a law enforcement  
23 agency of the State or a political subdivision of the State.

24           (5)       (i)       This subsection does not prohibit access to and use of a court  
25 record by a judicial officer who is authorized under the Maryland Rules to determine  
26 a defendant's eligibility for pretrial release, counsel for the defendant, or the State's  
27 Attorney if:

- 28                                       1.       The individual who is the subject of the court record is  
29 charged as an adult with an offense;
- 30                                       2.       The access to and use of the court record is strictly limited  
31 for the purpose of determining the defendant's eligibility for pretrial release; and
- 32                                       3.       The court record concerns an adjudication of delinquency  
33 that occurred within 3 years of the date the individual is charged as an adult.

34                       (ii)       The Court of Appeals may adopt rules to implement the  
35 provisions of this paragraph.



## Article 27 - Crimes and Punishments

3 (a) In any case, except as provided in subsection (b), involving a child who has  
4 reached 14 years of age but has not reached 18 years of age at the time of any alleged  
5 offense excluded under the provisions of [§ 3-804(e)(1) or (4)] § 3-804(E)(1), (4), OR (5) of  
6 the Courts and Judicial Proceedings Article, the court exercising jurisdiction may  
7 transfer the case to the juvenile court if a waiver is believed to be in the interests of the  
8 child or society.

9 (b) The court may not transfer a case to the juvenile court under subsection (a)  
10 if:

11 (1) The child has previously been waived to juvenile court and  
12 adjudicated delinquent;

13 (2) The child was convicted in another unrelated case excluded from the  
14 jurisdiction of the juvenile court under § 3-804(e)(1) or (4) of the Courts and Judicial  
15 Proceedings Article; or

16 (3) The alleged offense is murder in the first degree and the accused child  
17 is 16 or 17 at the time the alleged offense was committed.

19 (a) As used in this subtitle, the following words have the meanings indicated.

20 (e) "Criminal history record information" means data initiated or collected by  
21 a criminal justice agency on a person pertaining to a reportable event and includes  
22 data from an agency that is required to report to the central repository under Title 12  
23 of the Health - General Article. The term does not include:

24 (1) Data contained in intelligence or investigatory files or police  
25 work-product records used solely for police investigation purposes;

26 (2) Data pertaining to a proceeding under Subtitle 8 of Title 3 of the  
27 Courts Article (Juvenile Causes), but it does include:

28 (i) Data pertaining to a person following waiver of jurisdiction by a  
29 juvenile court; and

30 (ii) Information described under § 747(a)(21) AND (22) and § 747A of  
31 this subtitle;

32 (3) Wanted posters, police blotter entries, court records of public judicial  
33 proceedings, or published court opinions;

34 (4) Data pertaining to violations of the traffic laws of the State or any  
35 other traffic law, ordinance, or regulation, or violations of any local ordinances, or any

1 State or local regulations, or violations of the Natural Resources Article or public local  
2 laws;

3 (5) Data concerning the point system established by the Motor Vehicle  
4 Administration in accordance with the provisions of Title 16 of the Transportation  
5 Article; or

6 (6) Presentence investigation and other reports prepared by a probation  
7 department for use by a court in the exercise of criminal jurisdiction or by the  
8 Governor in the exercise of his power of pardon, reprieve, commutation, or nolle  
9 prosequi.

10 (f) "Criminal justice agency" means any government agency or subunit of any  
11 such agency which is authorized by law to exercise the power of arrest, detention,  
12 prosecution, adjudication, correctional supervision, custodial treatment or  
13 confinement under Title 12 of the Health - General Article, rehabilitation, or release  
14 of persons suspected, charged, or convicted of a crime or relieved of criminal  
15 punishment by a verdict of not criminally responsible, or is responsible for criminal  
16 identification activities and the collection, storage, and dissemination of criminal  
17 history record information, and which allocates a substantial portion of its annual  
18 budget to any of these functions. The term does not include the Department of  
19 Juvenile Justice or a juvenile court, except as provided under § 747(a)(21) AND (22)  
20 and § 747A of this subtitle, but it does include the following agencies, when exercising  
21 jurisdiction over criminal matters or alternative dispositions of criminal matters, or  
22 criminal history record information:

23 (1) State, county, and municipal police departments and agencies,  
24 sheriffs' offices, correctional facilities, jails, and detention centers;

25 (2) Any agency required to report to the central repository under §  
26 12-107 or § 12-112 of the Health - General Article;

27 (3) The offices of the Attorney General, the State's Attorneys, and any  
28 other person authorized by law to prosecute persons accused of criminal offenses; or

29 (4) The Administrative Office of the Courts, the Court of Appeals, the  
30 Court of Special Appeals, the circuit courts, the District Court of Maryland, and the  
31 offices of the clerks of these courts.

33 (a) The following events are reportable events under this subtitle:

34 (1) Issuance or withdrawal of an arrest warrant;

35 (2) An arrest;

36 (3) Release of a person after arrest without the filing of a charge;

- 1 (4) Presentment of an indictment, filing of a criminal information, or  
2 filing of a statement of charges after arrest;
- 3 (5) A release pending trial or appeal;
- 4 (6) Commitment to a place of pretrial detention;
- 5 (7) Dismissal or quashing of an indictment or criminal information;
- 6 (8) A nolle prosequi;
- 7 (9) Placement of a charge on the stet docket;
- 8 (10) An acquittal, conviction, verdict of not criminally responsible, or  
9 other disposition at or following trial, including a finding of probation before  
10 judgment;
- 11 (11) Imposition of a sentence;
- 12 (12) Commitment to a correctional facility, whether State or locally  
13 operated;
- 14 (13) Commitment to the Department of Health and Mental Hygiene  
15 under § 12-105 or § 12-111 of the Health - General Article as incompetent to stand  
16 trial or not criminally responsible;
- 17 (14) Release from detention or confinement;
- 18 (15) Conditional release, revocation of conditional release, or discharge of

4 criminal justice proceedings declared to be reportable by rule or regulation of the  
5 Secretary or the Court of Appeals.

7 (a) Except as provided in subsection (b) of this section, notwithstanding any  
8 other provision of this subtitle, no record may be maintained or disseminated in a  
9 manner inconsistent with the provisions of § 3-828 of the Courts and Judicial  
10 Proceedings Article.

11 (b) Notwithstanding § 3-828(a) of the Courts and Judicial Proceedings Article,  
12 a reportable event described under § 747(a)(21) AND (22) of this subtitle and  
13 fingerprinting of a child required under § 747A of this subtitle need not be maintained  
14 separate and apart from those of adults.

19 (i) Meets the definition in §§ 2-120 and 2-121 of this article; and

20 (ii) Provides residential services to youth placed by the
