A BILL ENTITLED

1 AN ACT concerning

2 **Washington County Museum of Fine Arts - Board of Trustees - Membership**

3 FOR the purpose of authorizing the Board of Trustees for the Washington County

4 Museum of Fine Arts to appoint up to a certain number of additional trustees.

5 BY repealing and reenacting, without amendments,

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

16 MARYLAND, That the Laws of Maryland read as follows:

17 **Article 22 - Washington County**

18 12-101.

19 (a) In this subtitle, the following words have the meanings indicated.

20 (b) "Board" means the Board of Trustees of the Washington County Museum of
21 Fine Arts.

22 (c) "Museum" means the Washington County Museum of Fine Arts.

23 12-102.

24 (a) There is a Board of Trustees of the Washington County Museum of Fine
25 Arts.

1 (b) The Board consists of 18 trustees as follows:

2 (1) 15 trustees appointed by the Board;

3 (2) As an ex officio member, the President of the Board of County
4 Commissioners or a County Commissioner designated by the President;

5 (3) As an ex officio member, the Superintendent of Schools of
6 Washington County; and

7 (4) As an ex officio member, the Mayor of the City of Hagerstown or a
8 City Council member designated by the Mayor.

9 (c) THE BOARD MAY APPOINT UP TO SIX ADDITIONAL TRUSTEES.

10 (D) (1) Each trustee serves for a term of 5 years.

11 (2) The terms of the trustees are staggered as required by the terms of
12 the trustees serving on July 1, 1988.

13 (3) A trustee serves only for the remainder of a term if the trustee is
14 appointed:

15 (i) To fill a vacancy in an unexpired term; or

16 (ii) To succeed a trustee who is holding over.

17 (4) A trustee serves until the successor of the trustee is appointed and
18 qualifies.

19 [(d)] (E) On taking office, each trustee shall take the oath required by Article
20 I, § 9 of the Maryland Constitution.

21 12-103.

22 In order to create and maintain a public museum known as the Washington
23 County Museum of Fine Arts in the City of Hagerstown for the use of the inhabitants
24 of Washington County, the Board may:

25 (1) Purchase, acquire, lease, or hold in any manner real property that is
26 necessary for the purposes of the museum;

27 (2) Receive any money or property that is donated to the museum;

28 (3) Use museum funds for property for:

29 (i) Maintenance and support of the museum;

30 (ii) Acquisition or purchase of art objects and other exhibits, and
31 necessary equipment;

- 1 (iii) Educational purposes; and
- 2 (iv) Purposes expressed at the direction of donors if accepted by the
3 Board;
- 4 (4) Sell, invest, or exchange any museum property to serve the interests
5 and welfare of the museum;
- 6 (5) Adopt and enforce regulations for the museum;
- 7 (6) Contract for the employment of a museum director and other
8 necessary personnel;
- 9 (7) Contract with the County Commissioners and the Mayor and Council
10 of Hagerstown to receive revenue for the museum; and
- 11 (8) Perform other acts necessary to maintain a public museum for the
12 use of the inhabitants of Washington County.
- 13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
14 October 1, 1998.
