- 8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be
- 9 construed retroactively and shall be applied to and interpreted to affect volunteer
- 10 firefighters and individuals serving on volunteer rescue squads who have died, on or
- 11 after January July 1, 1996, while fighting a fire or performing any official task under
- 12 circumstances that would cause the Board of Trustees of the Maryland State
- 13 Firemen's Association to pay death benefits under this Act.
