BE IT ENACTED BY THE GENERAL ASSEMBLY OF 13 MARYLAND, That the Laws of Maryland read as follows: 14 **Article - Health Occupations** 15 8-317. Except as otherwise provided in the Administrative Procedure Act AND IN 16 (a) 17 SUBSECTION (G) OF THIS SECTION, before the Board takes any action under § 8-312, 18 § 8-316, or § 8-404 of this title, it shall give the person against whom the action is 19 contemplated an opportunity for a hearing before the Board.

The Board shall give notice and hold the hearing in accordance with the

- 1 (c) The hearing notice to be given to the person shall be sent by certified mail,
- 2 return receipt requested, bearing a postmark from the United States Postal Service,
- 3 to the last known address of the person at least 30 days before the hearing.
- 4 (d) The person may be represented at the hearing by counsel.
- 5 (e) If after due notice the individual against whom the action is contemplated
- 6 fails or refuses to appear, nevertheless the Board may hear and determine the matter.
- 7 (f) Over the signature of the president or the executive director of the Board,
- 8 the Board may issue subpoenas and administer oaths in connection with any
- 9 investigation under this title and any hearings or proceedings before it.
- 10 (G) THE BOARD MAY IMMEDIATELY SUSPEND THE LICENSE OF A REGISTERED
- 11 NURSE OR LICENSED PRACTICAL NURSE WHO IS EXPELLED FROM THE
- 12 REHABILITATION PROGRAM UNDER § 8-208 OF THIS TITLE FOR NONCOMPLIANCE
- 13 WITH THE NURSE'S AGREEMENT IF:
- 14 (1) PRIOR TO SUSPENDING THE LICENSE, THE BOARD PROVIDES THE
- 15 NURSE WITH AN OPPORTUNITY TO SHOW CAUSE BY WRITTEN COMMUNICATION OR
- 16 NONTESTIMONIAL PRESENTATION AS TO WHY THE SUSPENSION SHOULD NOT
- 17 OCCUR: AND
- 18 (2) THE BOARD PROVIDES THE NURSE WITH AN OPPORTUNITY FOR A
- 19 HEARING, WHICH:
- 20 (I) SHALL OCCUR WITHIN 30 DAYS OF WRITTEN REQUEST BY THE
- 21 NURSE; AND
- 22 (II) SHALL IMPOSE ON THE LICENSEE THE BURDEN OF PROVING BY
- 23 A PREPONDERANCE OF THE EVIDENCE THAT THE LICENSEE IS NOT ADDICTED TO
- 24 DRUGS OR ALCOHOL.
- 25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 26 October 1, 1998.
