# A BILL ENTITLED

### 1 AN ACT concerning

## State Board of Veterinary Medical Examiners - Grounds for Discipline

3 FOR the purpose of authorizing the State Board of Veterinary Medical Examiners to

- 4 discipline a veterinarian who is disciplined in another state under certain
- 5 circumstances; and generally relating to the Board of Veterinary Medical
- 6 Examiners and grounds for discipline.

7 BY repealing and reenacting, with amendments,

## 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

13 MARYLAND, That the Laws of Maryland read as follows:

## **Article - Agriculture**

15 2-310.

16 The Board may prescribe reasonable standards for the practice of veterinary

- 17 medicine, including conduct and ethics. It may refuse, suspend, or revoke any
- 18 application or license, and censure or place on probation any licensee after a hearing,
- 19 if the veterinarian:
- 20 (1) Is adjudicated insane;
- 21 (2) Is convicted of a violation of any federal or State law relating to 22 prescription drugs, a controlled dangerous substance under Article 27, § 279 of the 23 Code, or a controlled substance as defined by 21 U.S.C. § 812;
- 24 (3) Is convicted of a felony, or of a crime involving moral turpitude;
- (4) Is convicted of violating any provision of this subtitle, any unlawful or
  fraudulent practice, or any fraudulent, misleading, or deceptive representation or

advertising concerning his professional qualifications or the quality of materials or
 drugs used by him in his professional work or in the treatment of animals;

3 (5) Has a final judgment entered against him in a civil malpractice case 4 involving gross personal negligence;

5 (6) Obtains the license by fraud or misrepresentation, either in the 6 application, or in passing the examination;

7 (7) Is guilty of employing or permitting to practice veterinary medicine 8 any person who does not hold a license to practice veterinary medicine in the State;

9 (8) Fails to comply with Board rules or regulations after receiving a 10 license;

11 (9) Is grossly negligent or deliberately cruel to an animal; [or]

12 (10) After a hearing, is determined by four members to be incompetent as 13 a veterinary practitioner; OR

14 (11) IS DISCIPLINED BY A LICENSING AUTHORITY OF ANOTHER STATE,
15 INCLUDING THE SUSPENSION OR REVOCATION OF A LICENSE TO PRACTICE
16 VETERINARY MEDICINE, FOR AN ACT THAT WOULD BE GROUNDS FOR DISCIPLINARY
17 ACTION UNDER THIS SECTION.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take 19 effect October 1, 1998.
