A BILL ENTITLED

1 AN ACT concerning

2 **Natural Resources - Phragmites - Biennial Reports**

3 FOR the purpose of requiring the Department of Natural Resources to determine the
4 spread of phragmites on a per-acre basis and to prepare biennial reports on the
5 extent of infestation; providing for a delayed effective date; and generally
6 relating to the management and control of phragmites in the State.

7 BY repealing and reenacting, with amendments,
8 Article - Natural Resources
9 Section 8-2101 and 8-2103
10 Annotated Code of Maryland
11 (1990 Replacement Volume and 1997 Supplement)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article - Natural Resources**

15 8-2101.

16 The General Assembly finds that the growth of the tall, reed-like grass
17 Phragmites communis, commonly known as phragmites, may be a public and common
18 nuisance on land and wetlands used for wildlife habitat areas. THEREFORE, IT IS THE
19 INTENT OF THE GENERAL ASSEMBLY THAT THIS SUBTITLE REQUIRE THAT
20 STATEWIDE STUDIES OF PHRAGMITES BE CONDUCTED IN ORDER TO DETERMINE ITS
21 SPREAD AND DETERMINE ANY PROGRESS MADE IN CURRENT MANAGEMENT AND
22 CONTROL PROGRAMS.

24 (a) (1) The Department shall study and analyze the effectiveness of the cost
25 sharing program in the Department that assists landowners in paying for the cost of
26 the management and control of the spread of phragmites.

27 (2) The analysis required in paragraph (1) of this subsection shall
28 include information on how assistance under the cost sharing program is allocated.

1 (b) The Department of Natural Resources SHALL ASCERTAIN ON A PER-ACRE
2 BASIS THE STATEWIDE EXTENT OF INFESTATION OF PHRAGMITES AND shall study
3 and analyze the progress made in the management and control of the spread of
4 phragmites on:

5 (1) Lands that the Department of Natural Resources owns or controls;
6 and

7 (2) Any real property on which the Department of Natural Resources
8 assists landowners with the control of phragmites.

9 (c) (1) The Department shall annually submit a report under subsections (a)
10 and (b) of this section to:

11 [(1)] (I) The Environmental Matters Committee of the House of
12 Delegates of Maryland; and

13 [(2)] (II) The Economic and Environmental Affairs Committee of the
14 Senate of Maryland.

15 (2) BEGINNING IN 2000, THE DEPARTMENT SHALL BIENNIALY SUBMIT
16 A REPORT ON THE EXTENT OF INFESTATION OF PHRAGMITES ON A PER-ACRE BASIS
17 TO:

18 (I) THE ENVIRONMENTAL MATTERS COMMITTEE OF THE HOUSE
19 OF DELEGATES OF MARYLAND; AND

20 (II) THE ECONOMIC AND ENVIRONMENTAL AFFAIRS COMMITTEE
21 OF THE SENATE OF MARYLAND.

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 October 1, 1998.
