A BILL ENTITLED

1 AN ACT concerning

2 **Garrett County - Sheriff's Office Employees - Classified Service**

3 FOR the purpose of providing that deputy sheriffs and other employees of the Garrett
4 County Sheriff's Office are included in the Garrett County classified service
5 system; excluding from the classified service the Sheriff and Chief Deputy
6 Sheriff; and generally relating to employees of the Garrett County Sheriff's
7 Office and civil service protection.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article - Courts and Judicial Proceedings**

16 2-309.

17 (m) (1) (i) The Sheriff of Garrett County shall receive:

18 1. \$28,250 for calendar year 1991;

19 2. \$30,500 for calendar year 1992;

20 3. \$32,750 for calendar year 1993;

21 4. \$35,000 for calendar year 1994; and

22 5. For each subsequent year, the salary set by the County
23 Commissioners in accordance with Chapter 91 of the Public Local Laws of Garrett
24 County.

1 (ii) The Sheriff is entitled to a sum set by the County
2 Commissioners, for expenses.

3 (2) The Sheriff shall employ deputies as needed, within the budgetary
4 limits, at salaries of at least \$5,200 each, one of whom shall act as warden of the jail,
5 and a matron for the jail who shall also perform clerical duties at the salary set by the
6 Sheriff. The Sheriff may employ additional special deputies whose compensation shall
7 be approved by the County Commissioners.

8 (3) The Sheriff and the deputy sheriffs shall be allowed extra car mileage
9 and out-of-county mileage at the rate of 14 cents per mile. This mileage allowance
10 shall not be payable if the Sheriff's office is furnished with automobiles.

11 (4) The Sheriff shall be reimbursed for the expenses of boarding
12 prisoners committed to the county jail, to be paid monthly upon vouchers submitted
13 by him to the County Commissioners of Garrett County. He shall also submit with
14 these vouchers an affidavit sworn to by him upon personal knowledge showing for
15 each day of the month just passed the number of prisoners boarded by him. The
16 Sheriff may appoint a cook for the jail who shall receive a salary of at least \$2,400.
17 The Sheriff, deputies, and cook shall each receive an additional allowance of \$200 per
18 year for uniforms and cleaning.

19 (5) (I) THIS PARAGRAPH DOES NOT APPLY TO THE SHERIFF OR CHIEF
20 DEPUTY SHERIFF.

21 (II) DEPUTY SHERIFFS AND OTHER EMPLOYEES OF THE SHERIFF'S
22 OFFICE ARE INCLUDED IN THE GARRETT COUNTY CLASSIFIED SERVICE SYSTEM.

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
24 October 1, 1998.
