1 AN ACT concerning

2 Calvert County - Gambling Permit Review Committee - Quorum

- 3 FOR the purpose of expanding the membership of the Calvert County gambling
- 4 permit review committee to include a certain number of alternate members;
- 5 establishing a quorum for the committee; allowing the chairman of the
- 6 committee to make a quorum under certain circumstances by designating a
- 7 certain number of alternate members as regular members; allowing an alternate
- 8 member to participate on the committee only under certain circumstances; and
- 9 generally relating to the Calvert County gambling permit review committee.
- 10 BY repealing and reenacting, with amendments,
- 11 Article 27 Crimes and Punishments

- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 16 MARYLAND, That the Laws of Maryland read as follows:

17 Article 27 - Crimes and Punishments

- 19 (i) (1) In Calvert County a volunteer fire company, or bona fide fraternal,
- 20 civic, war veterans', religious or charitable organization or corporation may conduct or
- 21 hold any carnival, bazaar, or gaming event in accordance with subsection (b) of this
- 22 section if the County Commissioners of Calvert County grant a permit that specifies
- 23 the nature of the gaming device and the frequency with which the carnival, bazaar, or
- 24 gaming event shall be held.
- 25 (2) The County Commissioners shall appoint a gambling permit review
- 26 committee consisting of [5] FIVE REGULAR members AND TWO ALTERNATE
- 27 MEMBERS.

- 1 (3) A QUORUM OF THE GAMBLING PERMIT REVIEW COMMITTEE 2 CONSISTS OF THREE REGULAR MEMBERS.
- 3 (4) IF FEWER THAN THREE REGULAR MEMBERS ARE PRESENT AT A
- 4 MEETING, THE CHAIRMAN OF THE COMMITTEE MAY MAKE A QUORUM BY
- 5 DESIGNATING FOR THAT MEETING THE REQUIRED NUMBER OF ALTERNATE
- 6 MEMBERS AS REGULAR MEMBERS.
- 7 (5) AN ALTERNATE MEMBER MAY PARTICIPATE ON THE COMMITTEE 8 ONLY AS SET FORTH IN PARAGRAPH (4) OF THIS SUBSECTION.
- 9 (6) The committee shall be responsible for promulgating regulations,
- 10 subject to approval by the commissioners, pertaining to gambling activities and the
- 11 issuance of permits under this subsection.
- 12 (7) The County Commissioners may charge a reasonable fee for the
- 13 issuance of the permit.
- 14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take
- 15 effect October 1, 1998.
