## Crimes - Resisting Arrest and Interference with Law Enforcement Officers

- 3 FOR the purpose of prohibiting a person from resisting a lawful arrest, knowingly
- and intentionally interfering with certain arrests or attempted arrests of 4
- 5 another, or knowingly and intentionally interfering with law enforcement
- officers engaged in certain duties; establishing penalties for a violation of this 6
- Act; providing that a sentence may be imposed separate from and consecutive to 7
- 8 or concurrent with certain sentences for certain other offenses; providing that
- the Committee Note contained in this Act is not law; and generally relating to 9
- 10 resisting arrest and interference with a law enforcement officer.

- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 17 MARYLAND, That the Laws of Maryland read as follows:
- 18 **Article 27 - Crimes and Punishments**
- 19 26A.
- 20 (A)(1) A PERSON MAY NOT RESIST A LAWFUL ARREST.
- A PERSON MAY NOT KNOWINGLY AND INTENTIONALLY INTERFERE 21 (2)
- 22 WITH A LAW ENFORCEMENT OFFICER WHO IS ATTEMPTING TO MAKE OR HAS MADE
- 23 AN ARREST OF ANOTHER.
- 24 A PERSON MAY NOT KNOWINGLY AND INTENTIONALLY INTERFERE
- 25 WITH A LAW ENFORCEMENT OFFICER WHO IS ENGAGED IN THE LAWFUL
- 26 PERFORMANCE OF DUTY.

- 1 (B) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A MISDEMEANOR
- 2 AND ON CONVICTION IS SUBJECT TO A FINE OF NOT MORE THAN \$2,500 OR
- 3 IMPRISONMENT FOR NOT MORE THAN 3 YEARS OR BOTH.
- 4 (C) A SENTENCE THAT IS IMPOSED FOR A VIOLATION OF THIS SECTION MAY
- 5 BE IMPOSED SEPARATE FROM AND CONSECUTIVE TO OR CONCURRENT WITH A
- 6 SENTENCE FOR ANY OTHER OFFENSE BASED ON THE ACT OR ACTS ESTABLISHING
- 7 THE VIOLATION.
- 8 COMMITTEE NOTE (COMMITTEE TO REVISE ARTICLE 27): This section is
- 9 intended to codify the common law offenses of resisting arrest, obstructing, hindering,
- 10 and interfering. No substantive changes are intended.
- 11 SECTION 2. AND BE IT FURTHER ENACTED, That the Committee Note
- 12 contained in this Act is not law.
- 13 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 14 October 1, 1998.
