A BILL ENTITLED

1 AN ACT concerning

2 Washington County - Alcoholic Beverages - Golf Courses

- 3 FOR the purpose of creating in Washington County certain Class C (golf course) beer
- and wine and beer, wine and liquor licenses for issuance to certain public golf
- 5 courses and organizations; establishing fees for certain licenses; limiting the
- area in which a licensee may sell alcoholic beverages; establishing that a patron
- does not need to be seated to be served by a licensee; establishing the hours that
- 8 a licensee may serve alcoholic beverages; and generally relating to serving
- 9 alcoholic beverages at golf courses in Washington County.

- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 16 MARYLAND, That the Laws of Maryland read as follows:
- 17 Article 2B Alcoholic Beverages
- 18 8-505.1.
- 19 (A) THIS SECTION APPLIES ONLY IN WASHINGTON COUNTY.
- 20 (B) IN THIS SECTION, "BOARD" MEANS THE BOARD OF LICENSE
- 21 COMMISSIONERS.
- 22 (C) (1) THE BOARD MAY ISSUE A 6-DAY CLASS C (GOLF COURSE) BEER AND
- 23 WINE (ON-SALE) LICENSE AND A 6-DAY CLASS C (GOLF COURSE) BEER, WINE AND
- 24 LIQUOR (ON-SALE) LICENSE.
- 25 (2) THE BOARD MAY ISSUE A SUNDAY CLASS C (GOLF COURSE) BEER
- 26 AND WINE (ON-SALE) LICENSE AND A SUNDAY CLASS C (GOLF COURSE) BEER, WINE
- 27 AND LIQUOR (ON-SALE) LICENSE.

- 1 (D) A LICENSE MAY BE ISSUED TO A PUBLIC GOLF COURSE OR ORGANIZATION 2 THAT HAS A REGULAR OR CHAMPIONSHIP GOLF COURSE WITH A MINIMUM OF NINE 3 HOLES.
- 4 (E) THE ANNUAL LICENSE FEE IS:
- $5\ \ \,$ (1) $\ \ \,$ \$750 FOR A 6-DAY CLASS C (GOLF COURSE) BEER AND WINE 6 (ON-SALE) LICENSE;
- 7 (2) \$1,000 FOR A 6-DAY CLASS C (GOLF COURSE) BEER, WINE AND 8 LIQUOR (ON-SALE) LICENSE;
- 9 $\,$ (3) $\,$ \$250 FOR A SUNDAY CLASS C (GOLF COURSE) BEER AND WINE 10 (ON-SALE) LICENSE; AND
- 11 (4) \$250 FOR A SUNDAY CLASS C (GOLF COURSE) BEER, WINE AND 12 LIQUOR (ON-SALE) LICENSE.
- 13 (F) SUBJECT TO THE APPROVAL OF THE BOARD OF LICENSE COMMISSIONERS,
- 14 A LICENSEE UNDER THIS SECTION MAY SELL ALCOHOLIC BEVERAGES FOR
- 15 CONSUMPTION ONLY ON THE LAND AND IN THE BUILDINGS, INCLUDING THE
- 16 CLUBHOUSE, USED FOR GOLFING PURPOSES.
- 17 (G) A PATRON NEED NOT BE SEATED TO BE SERVED ALCOHOLIC BEVERAGES.
- 18 (H) (1) THE HOURS AND DAYS OF SALE ARE AS SPECIFIED IN § 11-522 OF 19 THIS ARTICLE.
- 20 (2) THE BOARD MAY REDUCE A LICENSEE'S HOURS OF SALE OF 21 ALCOHOLIC BEVERAGES FOR ALL OR A PORTION OF THE LICENSED PREMISES.
- 22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 23 June 1, 1998.
