A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore County - Community Colleges - Change of Name**

3 FOR the purpose of restructuring the system of community colleges in Baltimore
4 County by creating the Community College of Baltimore County with a certain
5 number of campuses; changing the names of certain existing community colleges
6 in Baltimore County; and generally relating to community colleges in Baltimore
7 County.

8 BY repealing and reenacting, with amendments,

10 Section 16-105
11 Annotated Code of Maryland
12 (1997 Replacement Volume and 1997 Supplement)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article - Education**

16 16-105.

17 (a) Notwithstanding the provisions of § 16-104 of this subtitle, the provisions
18 of this section shall apply only in Baltimore County.

19 (B) THERE IS A COMMUNITY COLLEGE OF BALTIMORE COUNTY CONSISTING
20 OF THE FOLLOWING THREE CAMPUSES:

- 21 (1) THE CATONSVILLE CAMPUS;
22 (2) THE DUNDALK CAMPUS; AND
23 (3) THE ESSEX CAMPUS.

24 [(b)] (C) The Board of Trustees for Baltimore County shall appoint a
25 Chancellor of the [community colleges in] COMMUNITY COLLEGE OF Baltimore
26 County who shall serve at the pleasure of the Board.

1 [(c)] (D) The Chancellor:

2 (1) Shall report directly to the Board of Trustees;

3 (2) Shall recommend the appointment by the Board of qualified faculty
4 members and other employees necessary for the efficient administration of the
5 [community colleges in] COMMUNITY COLLEGE OF Baltimore County;

6 (3) Shall recommend the discharge of employees for good cause; however,
7 any employee with tenure shall be given reasonable notice of the grounds for
8 dismissal and an opportunity to be heard;

9 (4) Is responsible for the administration and supervision of the
10 presidents, employees, and departments of the [community colleges in] CAMPUSES
11 OF THE COMMUNITY COLLEGE OF Baltimore County in accordance with the policy
12 manual of the COMMUNITY COLLEGE OF Baltimore County [community colleges] as
13 adopted from time to time by the Board of Trustees; and

14 (5) Shall attend all meetings of the Board, except those involving the
15 Chancellor's personal position.

16 [(d)] (E) Upon the recommendation of the Chancellor, the Board of Trustees
17 may appoint a president of each [community college] CAMPUS under its jurisdiction.

18 [(e)] (F) The presidents of each [Baltimore County community college]
19 CAMPUS shall report directly to the Chancellor.

20 [(f)] (G) Notwithstanding the provisions of § 16-102(a)(2) of this subtitle, the
21 Board of Trustees may choose the Chancellor to serve as Secretary-Treasurer of the
22 Board.

23 [(g)] (H) Notwithstanding the provisions of § 16-103(f)(2) of this subtitle, the
24 Chancellor may execute a conveyance or other legal document under an appropriate
25 resolution of the Board of Trustees.

26 [(h)] (I) Notwithstanding the provisions of § 16-103(m) of this subtitle, the
27 Board of Trustees shall be styled "the Board of Trustees of the [Community Colleges
28 of] COMMUNITY COLLEGE OF Baltimore County".

29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
30 October 1, 1998.
