- 27 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

THE ADMINISTRATION MAY ISSUE IN ACCORDANCE WITH THIS 3 (A) 4 SECTION SPECIAL REGISTRATION PLATES THAT IDENTIFY THE VEHICLE DISPLAYING 5 THE PLATES AS BEING OWNED BY AN INDIVIDUAL WHO HAS BEEN CONVICTED OF A 6 VIOLATION OF § 21-902 OF THIS ARTICLE. 10 11	(a) (1) A person may not drive or attempt to drive any vehicle while intoxicated.
12 13	(2) A person may not drive or attempt to drive any vehicle while the person is intoxicated per se.
14 15	(b) A person may not drive or attempt to drive any vehicle while under the influence of alcohol.
	(c) (1) A person may not drive or attempt to drive any vehicle while he is so far under the influence of any drug, any combination of drugs, or a combination of one or more drugs and alcohol that he cannot drive a vehicle safely.
21 22	(2) It is not a defense to any charge of violating this subsection that the person charged is or was entitled under the laws of this State to use the drug, combination of drugs, or combination of one or more drugs and alcohol, unless the person was unaware that the drug or combination would make him incapable of safely driving a vehicle.
26	(d) A person may not drive or attempt to drive any vehicle while he is under the influence of any controlled dangerous substance, as that term is defined in Article 27, § 279 of the Code, if the person is not entitled to use the controlled dangerous substance under the laws of this State.
28 29	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 1998.
