## A BILL ENTITLED

1 AN ACT concerning

## Baltimore County Board of Education - Election of Members

3 FOR the purpose of repealing the authority of the Governor to appoint certain 4 members of the Baltimore County Board of Education; altering the number of 5 members of the Board; providing for the election of the members of the Board, 6 except for the student member; specifying the terms of the members initially 7 elected to the Baltimore County Board of Education; specifying that certain 8 incumbent members shall continue to serve until the elected members take 9 office; terminating the terms of the incumbent appointed members; and 10 generally relating to the election of the members of the Baltimore County Board 11 of Education.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

23 [(a) The Baltimore County Board consists of 12 members who shall be 24 appointed as follows:
(1) Four from the County at large;

 8 changed, the term of an incumbent member of the County Board who no longer 9 resides in the [legislative] COUNCILMANIC district because of the change is not 10 affected during this term.11 [(e)] (G) There is a School Shared Space Council in Baltimore County 12 consisting of 12 employees of the County appointed by the County Executive for a 13 term coterminous with that of the Board as follows:

15 (2) Two from the County Executive's administrative staff, one of whom 16 shall be the Director of Central Services;

17 (3) One from the Department of Social Services;

$31 \quad[(\mathrm{~g})] \quad$ (I) In addition to the County employee members, there shall be eight
32 County citizens selected as members of the Council as follows and with the following
33 duties:
(1) The County citizen members shall be selected by the County 2 Executive. One member shall be selected from each legislative district of Baltimore 3 County with the approval of the State Senator from that district. Each legislative 4 district representative shall reside in that district;
(2) The initial members selected to represent legislative districts 5, 7, 9, 6 and 11 shall each serve for a 2 -year term beginning June 1, 1979, and ending May 31, 7 1981. Thereafter all members shall be selected to serve 2-year terms. The initial 8 members selected to represent legislative districts $8,10,12$, and 13 shall each serve 9 for a 1 -year term beginning June 1, 1979, and ending May 31, 1980, and thereafter 10 all members shall be selected for 2-year terms;

SECTION 2. AND BE IT FURTHER ENACTED, That, notwithstanding § 7 3-2A-01(b) of the Education Article, the initial terms of members of the Baltimore 8 County Board of Education elected in November 1998 shall be as follows:

10 the members elected from councilmanic districts shall each serve a term of 4 years;

SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take 24 effect July 1, 1998.
