CHAPTER\_\_\_\_\_

1 AN ACT concerning

2 **Cecil County - Commission for Women**

3 FOR the purpose of establishing the Cecil County Commission for Women; providing  
4 for the membership and terms of the Commission's members; establishing the  
5 powers and duties of the Commission; and generally relating to the Cecil County  
6 Commission for Women.

7 BY adding to  
8 The Public Local Laws of Cecil County  
9 Section 84-1 through ~~84-6~~ 84-5 to be under the new chapter "Chapter 84.  
10 Women, Commission for"  
11 Article 8 - Public Local Laws of Maryland  
12 (1989 Edition and June 1997 Supplement, as amended)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article 8 - Cecil County**

16 CHAPTER 84. WOMEN, COMMISSION FOR

17 84-1.

18 A. THERE IS A CECIL COUNTY COMMISSION FOR WOMEN.

19 B. THE PURPOSE OF THE COMMISSION IS TO RAISE AWARENESS OF ISSUES  
20 AFFECTING WOMEN AND FAMILIES AND TO ADVOCATE FOR WOMEN AND FAMILIES

1 IN ORDER TO ASSIST THEM IN ATTAINING THE BEST QUALITY OF LIFE FOR  
2 THEMSELVES AND THEIR FAMILIES.

3 84-2.

4 A. (1) THE COMMISSION SHALL CONSIST OF 12 MEMBERS.

5 (2) THE MEMBERS SHALL REPRESENT A CROSS SECTION OF THE  
6 COUNTY AND SHALL BE SELECTED BECAUSE OF THEIR KNOWN EXPERIENCE AND  
7 ACTIVE INTEREST IN ~~WOMEN'S~~ WOMEN AND FAMILY ISSUES AND THE PURPOSES OF  
8 THE COMMISSION.

9 B. THE BOARD OF COUNTY COMMISSIONERS SHALL APPOINT THE INITIAL  
10 MEMBERS OF THE COMMISSION FROM A LIST SUPPLIED BY THE TASK FORCE FOR  
11 THE STUDY AND FORMATION OF A CECIL COUNTY COMMISSION FOR WOMEN.  
12 THEREAFTER, THE BOARD OF COUNTY COMMISSIONERS SHALL APPOINT MEMBERS  
13 FROM RECOMMENDATIONS MADE BY ORGANIZATIONS AND AGENCIES IN THE  
14 COUNTY DEDICATED TO IMPROVING THE QUALITY OF LIFE FOR THE CITIZENS OF  
15 CECIL COUNTY.

16 84-3.

17 A. (1) FOR THE INITIAL ESTABLISHMENT OF THE FIRST COMMISSION,  
18 ONE-THIRD OF THE MEMBERS SHALL SERVE FOR 1 YEAR, ONE-THIRD FOR 2 YEARS,  
19 AND ONE-THIRD FOR 3 YEARS. THEREAFTER, THE TERMS OF ALL MEMBERS SHALL  
20 BE 3 YEARS.

21 (2) AT THE END OF A TERM, A MEMBER OF THE COMMISSION  
22 CONTINUES TO SERVE UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.

23 (3) A MEMBER OF THE COMMISSION WHO IS APPOINTED AFTER A TERM  
24 HAS BEGUN SERVES ONLY FOR THE REST OF THE TERM AND UNTIL A SUCCESSOR IS  
25 APPOINTED AND QUALIFIES.

26 B. A MEMBER OF THE COMMISSION:

27 (1) MAY NOT RECEIVE COMPENSATION; BUT

28 (2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES, AS PROVIDED IN  
29 THE COMMISSION'S BUDGET.

30 C. THE COMMISSION SHALL SELECT FROM ITS OWN MEMBERSHIP A  
31 CHAIRPERSON, VICE-CHAIRPERSON, AND SECRETARY-TREASURER, EACH TO SERVE  
32 AT THE PLEASURE OF THE COMMISSION.

33 84-4.

34 A. THE COMMISSION SHALL MEET AS FREQUENTLY AS REQUIRED TO  
35 PERFORM ITS DUTIES, BUT NO LESS THAN ~~ONCE EACH MONTH, AND SHALL HOLD~~

~~1 SPECIAL MEETINGS AT THE CALL OF THE CHAIRPERSON OR OF ANY 3 MEMBERS OF  
2 THE COMMISSION TWO TIMES EACH YEAR.~~

~~3 B. A MEMBER OF THE COMMISSION WHO FAILS TO ATTEND AT LEAST 50% OF  
4 THE MEETINGS DURING A PERIOD OF 12 CONSECUTIVE MONTHS SHALL BE  
5 CONSIDERED TO HAVE RESIGNED.~~

~~6 C. THE COMMISSION SHALL ADOPT RULES AND REGULATIONS NECESSARY  
7 TO GOVERN ITS PROCEDURE AND BUSINESS.~~

~~9 THE COMMISSION SHALL SUBMIT AN ANNUAL REPORT TO THE COUNTY  
10 COMMISSIONERS SUMMARIZING ITS ACTIVITIES DURING THE PRECEDING YEAR, ITS  
11 RECOMMENDATIONS, AND THE STATUS OF WOMEN IN THE COUNTY.~~

~~14 (1) DEVELOP AN INFORMATION AND REFERRAL SYSTEM FOR ALL  
15 SERVICES IN THE COUNTY RELATED SPECIFICALLY TO THE NEEDS OF WOMEN AND  
16 TO RECOMMEND OTHER SERVICES WHEN THE NEED EXISTS;~~

~~17 (2) IDENTIFY, ANALYZE, AND DISSEMINATE INFORMATION THAT WILL  
18 ASSIST IN ELIMINATING DISCRIMINATION AGAINST WOMEN;~~

~~19 (3) DEVELOP AND IMPLEMENT PROGRAMS THAT WILL EXPAND  
20 WOMEN'S EDUCATIONAL AND EMPLOYMENT OPPORTUNITIES;~~

~~21 (4) RECOMMEND PROGRAMS OR LEGISLATION THAT IS NECESSARY AND  
22 PROPER TO PROMOTE AND ENSURE EQUAL RIGHTS AND OPPORTUNITIES FOR ALL  
23 PERSONS;~~

~~24 (5) CONDUCT WORKSHOPS AND EDUCATIONAL PROGRAMS RELATIVE TO  
25 WOMEN'S ISSUES;~~

~~26 (6) PROMOTE A POSITIVE IMAGE OF WOMEN BY RECOGNIZING THEIR  
27 ACCOMPLISHMENTS AND CONTRIBUTIONS TO THE COUNTY; AND~~

~~28 (7) WORK TO REMOVE INEQUALITY DUE TO UNMET NEED OR  
29 DISCRIMINATION ON THE BASIS OF GENDER IN THE COUNTY.~~

30 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
31 October 1, 1998.
