- 3 FOR the purpose of requiring the Secretary of the Department of Budget and
- 4 Management to establish a computer loan program; requiring the program to
- 5 provide below-market fixed rate loans for the purchase or upgrade of computers

- 19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 20 MARYLAND, That the Laws of Maryland read as follows:

21 Article - State Personnel and Pensions

- 23 (a) Except as provided in subsection (b) of this section and [§ 10-404] §§
- 24 10-404 AND 10-405 of this subtitle, this subtitle applies to all employees of all units in
- 25 the Executive Branch of State government.
- 26 (b) Except as provided in [§ 10-404] §§ 10-404 AND 10-405 of this subtitle, this
- 27 subtitle does not apply to a unit with an independent personnel system.

- 2 (A) THIS SECTION APPLIES TO ALL EMPLOYEES, EXCEPT TEMPORARY
- 3 EMPLOYEES, OF ALL UNITS IN THE EXECUTIVE, JUDICIAL, AND LEGISLATIVE
- 4 BRANCHES OF STATE GOVERNMENT, INCLUDING ANY UNIT WITH AN INDEPENDENT
- 5 PERSONNEL SYSTEM.
- $6 \hspace{0.1in} (B) \hspace{0.1in} (1)$ THE SECRETARY SHALL ESTABLISH A COMPUTER LOAN PROGRAM 7 WITHIN THE DEPARTMENT.
- 8 (2) THE PROGRAM SHALL PROVIDE BELOW-MARKET FIXED RATE LOANS
- 9 FOR THE PURCHASE OR UPGRADE OF A COMPUTER TO EMPLOYEES:
- 10 (I) WHO ARE ELIGIBLE TO PARTICIPATE IN A TELECOMMUTING
- 11 PROGRAM ADMINISTERED BY THE DEPARTMENT OR BY ANY OTHER UNIT OF STATE
- 12 GOVERNMENT; AND
- 13 (II) WHO NEED TO PURCHASE OR UPGRADE A COMPUTER IN ORDER 14 TO PARTICIPATE IN THE TELECOMMUTING PROGRAM.
- 15 (C) THE SECRETARY BY REGULATION SHALL ESTABLISH:
- 16 (1) PROCEDURES FOR APPLYING FOR A LOAN;
- 17 (2) CRITERIA FOR DETERMINING ELIGIBILITY FOR A LOAN; AND
- 18 (3) TERMS AND CONDITIONS FOR A LOAN, INCLUDING ANY LIMITATIONS
- 19 ON THE AMOUNT OF A LOAN, REPAYMENT TERMS FOR A LOAN, AND ANY REQUIRED
- 20 SECURITY FOR A LOAN.
- 21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 22 October 1, 1998.
