- 1 SECTION 3. AND BE IT FURTHER ENACTED, That the Department of
- 2 Budget and Management, for the purposes of review and comment, shall notify the
- 3 Senate Budget and Taxation Committee and the House Appropriations Committee
- 4 upon the selection of the State agencies that will participate in this Pilot Program.
- 5 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 6 October 1, 1998. It shall remain effective for a period of 3 years and, at the end of
- 7 September 30, 2001, with no further action required by the General Assembly, this
- 8 Act shall be abrogated and of no further force and effect.
