BE IT ENACTED BY THE GENERAL ASSEMBLY OF 18 MARYLAND, That the Laws of Maryland read as follows: 19 Article - Health - General 20 5-401.

In this subtitle the following words have the meanings indicated.

2 (c) "Public officer" means an officer of this State or of a county or other 3 political subdivision of this State.

"Board" means the State Anatomy Board.

- 5 (a) (1) A public officer who has control of a body immediately shall notify the 6 chairman of the Board if, after a reasonable search, the public officer has not found a 7 person who will take control of the body for its final disposition.
- 8 (2) Subject to the limitations imposed on nursing homes under Article 9 70B, § 5A of the Code, any other person who has control of a body may notify the 10 Board if, after a reasonable search, the person has not found a person who will take 11 control of the body for its final disposition.
- 12 (b) (1) Subject to the time limitations in this subsection, when the Board is 13 notified of the existence of a body, the Board may remove the body to a morgue in 14 Baltimore City that the Board designates for that purpose.
- 15 (2) If the person who notifies the Board can refrigerate the body suitably, 16 the body may be removed only at the expiration of [48 hours] 3 BUSINESS DAYS 72 HOURS after death.
- 18 (3) If the person who notifies the Board cannot refrigerate the body
  19 suitably, the body may be removed as soon as feasible after death, and, on arrival at
  20 the morgue, shall be refrigerated until the expiration of [48 hours] 3 BUSINESS DAYS
  21 72 HOURS after death.
- 22 (c) (1) On expiration of [48 hours] 3 BUSINESS DAYS 72 HOURS after death, 23 the body shall be under the exclusive control of the Board and may be embalmed.
- 24 (2) If the body is embalmed, it shall be embalmed in a proper manner by 25 an individual whom the Board designates.
- 26 (3) Any relative or friend of the deceased may claim the body and, on 27 payment to the Board of its cost of moving and embalming the body, shall receive it.
- 28 (4) The Board may waive its costs under this section upon a showing of 29 hardship by the relative or friend.
- 30 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 31 October 1, 1998.
