BE IT ENACTED BY THE GENERAL ASSEMBLY OF 2 MARYLAND, That the Laws of Maryland read as follows: 3 Article 33 - Election Code 4 13-206. 5 Prior to the time of filing the final report required by § 13-401 of this title, (d) 6 any surplus funds remaining after payment of all campaign expenditures shall be: 7 Returned, pro rata, to the contributors by the treasurer; (1) (2) Paid to the State central committee of the party of which the 9 candidate is a member or for which the political committee is acting; Paid to a central committee of the party of which the candidate is a 11 member or for which the political committee is acting so long as the central committee 12 is located in a county in which the candidate resides or seeks to represent; 13 Paid to the local board of education or to a recognized nonprofit 14 organization providing services or funds for the benefit of pupils or teachers;
- Paid to a charitable organization registered or exempt from 15 (5)16 registration under the Maryland Charitable Solicitations Act; or
- 17 (6)Paid to any public or private institution of higher education in this 18 State that possesses a certificate of approval from the Maryland Higher Education 19 Commission, to be used by that institution to award scholarships, grants, or loans to 20 students attending the institution.

- 22 A candidate for nomination or election to public or party office, including 23 write-in candidates, and the treasurer designated by that candidate shall file the 24 report or statement of contributions and expenditures as prescribed in accordance with § 13-402 of this subtitle with the board at which the candidate filed his 26 certificate of candidacy. All reports or statements of contributions and expenditures 27 shall be filed in duplicate except those filed with the State Board. Election reports as 28 specified below are required by all candidates for public or party office whether or not 29 the candidate's name appears on the primary ballot, or the candidate withdraws 30 subsequent to filing his certificate of candidacy, or the candidate is unsuccessful in 31 the election. Each report filed shall contain all contributions received and 32 expenditures made in furtherance of the candidate's nomination or election by the 33 candidate himself or, with the knowledge of the candidate, by any other person or 34 groups of persons, which shall be complete, except as otherwise provided in this 35 section through and including the seventh day immediately preceding the day by 36 which that report is to be filed. The initial report filed shall contain all contributions 37 so received and expenditures so made since the date of the last preceding election to 38 fill the office for which he is a candidate. Each subsequent report shall contain all

Even if no contributions or expenditures have 2 been made since the end of the period for which the last preceding report was filed, a 3 statement to that effect must be filed on the forms prescribed pursuant to § 13-402 of 4 this subtitle under the circumstances and at the times specified in this section. The 5 initial and subsequent reports shall be consecutively filed as follows: No later than the fourth Tuesday immediately preceding any primary 6 7 election; and No later than the second Friday immediately preceding any election 8 9 which shall be complete through and including the preceding Sunday; and 10 (3) No later than the third Tuesday after the general election; and 11 If a cash balance exists or if any unpaid bills or deficits remain to be 12 paid as of the end of the period for which the report or statement in paragraph (3) of 13 this subsection is filed, six months after the general election; and 14 If a cash balance exists or if any unpaid bills or deficits remain to be (5) 15 paid as of the end of the period for which the report or statement in paragraph (4) of 16 this subsection is filed, one year after the general election; and 17 If a cash balance exists or if any unpaid bills or deficits remain to be (6) 18 paid as of the end of the period for which the report or statement in paragraph (5) of 19 this subsection or any subsequent report or statement is filed, annually on the 20 anniversary of the general election until no cash balance, unpaid bill, or deficit 21 remains; and 22 If a cash balance or outstanding debts or deficits were reflected on 23 the last preceding report, but have all been eliminated by the date on which the next 24 report is due, then a report clearly marked as "final" shall be filed on or before such 25 date showing all transactions since the last report; and 26 If a candidate does not intend to receive contributions or make 27 expenditures of \$1,000 or more, exclusive of his filing fee, he and his treasurer may 28 jointly execute an affidavit to that effect on a form prescribed by the State Board. If 29 he does not in fact receive contributions or make expenditures of \$1,000 or more, no 30 further reports need be filed pursuant to this section. The affidavit shall be filed not 31 later than the date by which the first report is due. If at any time the cumulative 32 contributions to or expenditures by a candidate who has filed such an affidavit equal 33 or exceed \$1,000, he and his treasurer shall thereafter file all reports required by this 34 section and failure to do so constitutes a failure to file and the commission of a

- 1 (II)AFTER PAYMENT OF ALL OUTSTANDING DEBTS OR DEFICITS IN 2 CONNECTION WITH AN ELECTION CAMPAIGN, HAS A BALANCE OF SURPLUS FUNDS 3 IN A CAMPAIGN ACCOUNT. 4 AN INDIVIDUAL DESCRIBED IN PARAGRAPH (1) OF THIS SUBSECTION 5 SHALL FILE A FINAL REPORT UNDER THIS SECTION TO CLOSE OUT THE CAMPAIGN 6 ACCOUNTS OF THE INDIVIDUAL, AND EACH POLITICAL COMMITTEE AFFILIATED 7 WITH THE INDIVIDUAL, BY THE EXPIRATION OF THE FOURTH EIGHTH YEAR 8 FOLLOWING THE LATTER OF: THE END OF THE INDIVIDUAL'S MOST RECENT TERM OF (I) 10 OFFICE: 11 (II)THE DATE OF THE ELECTION IN WHICH THE INDIVIDUAL LAST 12 WAS A CANDIDATE; OR 13 (III)30 DAYS AFTER THE EXTINGUISHMENT OF EVERY DEBT OR THE 14 DEFICIT INCURRED IN CONNECTION WITH THE CAMPAIGN THAT IS PAYABLE FROM 15 THE ACCOUNT. PRIOR TO FILING THE FINAL CAMPAIGN REPORT REQUIRED UNDER 16 17 PARAGRAPH (1) OF THIS SUBSECTION, A PERSON SUBJECT TO PARAGRAPH (1) OF THIS 18 SUBSECTION SHALL DISPOSE OF ANY FUNDS IN ACCORDANCE WITH § 13-206(D) OF 19 THIS TITLE. 20 SECTION 2. AND BE IT FURTHER ENACTED, That, with regard to the 21 disposition of carryover funds from the 4-year election cycle that ends on December 22 31, 1998 which are, on the effective date of this Act, in the possession of a committee 23 that continues in existence from year to year that becomes subject to this Act on 24 January 1, 1999, the committee shall comply with the requirements of this Act by 25 December 31, 1999. 26 SECTION 2. AND BE IT FURTHER ENACTED, That, with regard to the 27 disposition of carryover funds which, on the effective date of this Act, are in the 28 campaign account of an individual or a political committee that continues in existence from year to year and that is subject to this Act, the individual responsible for the 30 campaign account shall file the campaign report to close out the account in
- 31 accordance with the requirements of this Act by December 31, 2006.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 32
- 33 January 1, 1999.
