A licensee may not permit or allow to remain in the water any pound or net stake for a period greater than 30 days following the removal of the net from each stake, or the discontinuance of fishing of the net AND MAY NOT PERMIT OR ALLOW ANY POUND OR STAKE NET POLES TO REMAIN IN THE WATER BETWEEN JANUARY 1 AND JANUARY 31, UNLESS THE OWNER OF THE POUND NET NOTIFIES THE DEPARTMENT THAT THE NET IS BEING ACTIVELY FISHED.
