# Baltimore City - The Eubie Blake National Jazz Institute and Cultural Center Loan of 1994

4 FOR the purpose of amending Chapter 220 of the Acts of the General Assembly of

- 5 1994, the Baltimore City Eubie Blake National Museum and Cultural Center
- 6 Loan of 1994, as amended by Chapter 322 of the Acts of the General Assembly of
- 7 1995, as amended by Chapter 12 of the Acts of the General Assembly of 1996, to
- 8 alter the title of the loan and the name of the institution that is to be the
- 9 recipient of the proceeds of the bonds to be The Eubie Blake National Jazz
- 10 Institute and Cultural Center, to alter the location of the Center to be 847 North
- 11 Howard Street in Baltimore City, and to alter the use of the proceeds of the
- 12 bonds.

## 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

19 MARYLAND, That the Laws of Maryland read as follows:

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

#### HOUSE BILL 1088

1 (1) The Board of Public Works may borrow money and incur indebtedness on

2 behalf of the State of Maryland through a State loan to be known as [the]THE Eubie

3 Blake National [Museum] JAZZ INSTITUTE and Cultural Center Loan of 1994 in a

4 total principal amount equal to the lesser of (i) \$250,000 or (ii) the amount of the

5 matching fund provided in accordance with Section 1(5) below. This loan shall be

6 evidenced by the issuance, sale, and delivery of State general obligation bonds

7 authorized by a resolution of the Board of Public Works and issued, sold, and

 $8\;$  delivered in accordance with §§ 8-117 through 8-124 of the State Finance and

9 Procurement Article and Article 31, § 22 of the Code.

10 (2) The bonds to evidence this loan or installments of this loan may be sold as 11 a single issue or may be consolidated and sold as part of a single issue of bonds under 12 § 8-122 of the State Finance and Procurement Article.

13 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer 14 and first shall be applied to the payment of the expenses of issuing, selling, and 15 delivering the bonds, unless funds for this purpose are otherwise provided, and then 16 shall be credited on the books of the Comptroller and expended, on approval by the Board of Public Works, for the following public purposes, including any applicable 17 18 architects' and engineers' fees: as a grant to [the] THE Eubie Blake National 19 [Museum] JAZZ INSTITUTE and Cultural Center, Inc. for the [razing of an existing 20 building and the planning, design, construction, and equipping of a new building at 21 Franklin and Howard Streets in Baltimore City, to be used as the Eubie Blake 22 National Museum and Cultural Center.] REPAIR, RENOVATION, RECONSTRUCTION, 23 CONSTRUCTION, AND CAPITAL EQUIPPING OF A BUILDING AT 847 NORTH HOWARD 24 STREET IN BALTIMORE CITY TO BE NAMED IN HONOR OF EUBIE BLAKE AND TO BE 25 USED AS A MODERN PERFORMING ARTS CENTER THAT WOULD BE A HOME FOR THE 26 WORK OF MINORITY ARTISTS AND WOULD PROVIDE AREA RESIDENTS WITH CLASSES 27 AND ACTIVITIES IN THE ARTS.

(4) An annual State tax is imposed on all assessable property in the State in
rate and amount sufficient to pay the principal of and interest on the bonds as and
when due and until paid in full. The principal shall be discharged within 15 years
after the date of issuance of the bonds.

32 Prior to the payment of any funds under the provisions of this Act for the (5)33 purposes set forth in Section 1(3) above, the Eubie Blake National Museum and 34 Cultural Center, Inc. shall provide and expend a matching fund. No part of an 35 applicant's matching fund may be provided, either directly or indirectly, from funds of 36 the State, whether appropriated or unappropriated. No part of the fund may consist of 37 real property, in kind contributions, or funds expended prior to the effective date of 38 this Act. In case of any dispute as to the amount of the matching fund or what money 39 or assets may qualify as matching funds, the Board of Public Works shall determine 40 the matter and the Board's decision is final. The Eubie Blake National [Museum] 41 JAZZ INSTITUTE and Cultural Center, Inc. has until June 1, 1996, to present evidence 42 satisfactory to the Board of Public Works that a matching fund will be provided. If 43 satisfactory evidence is presented, the Board shall certify this fact and the amount of 44 the matching fund to the State Treasurer, and the proceeds of the loan equal to the 45 amount of the matching fund shall be expended for the purposes provided in this Act.

#### **HOUSE BILL 1088**

Any amount of the loan in excess of the amount of the matching fund certified by the
 Board of Public Works shall be canceled and be of no further effect.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 3

4 June 1, 1998.
