16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

1 of sale or purchase or any contract for any county work, project, or other expenditure 2 to which the county is a party where the amount involved in the contract exceeds 3 \$25,000 without advertising for bids at least 1 week before the bid by publication in at 4 least one newspaper that is published in the county or through electronic media. 5 (b) A contract of sale shall be awarded to the highest responsible bidder. (1) 6 A contract of purchase or other expenditure shall be awarded to the (2)7 lowest responsible bidder. 8 If a bidder has not paid all taxes owed to the county or a municipal (3)corporation in the county, the County Commissioners may reject the bidder's bid. 9 10 (4)Notwithstanding the provisions of this subsection, the County 11 Commissioners may reject any bid. 12 (c) (1)Any contract entered into in violation of the provisions of this section 13 is void. 14 (2)The provisions of this section do not apply to: Any contract or other transaction involving the deposit of 15 (i) 16 county funds in any authorized State or federal banking institution; 17 (ii) Necessary repairs made in case of emergency; 18 (iii) The purchase of tangible personal property at a public auction; 19 or 20 (iv) Any contract for which the County Commissioners approve sole 21 source procurement under § 1-106.2 of this subtitle.

(D) SUBJECT TO § 1-301 OF THIS TITLE, THE COUNTY COMMISSIONERS MAY 23 ENTER INTO A CONTRACT OF SALE OR PURCHASE OF REAL ESTATE WITHOUT 24 ADVERTISING FOR BIDS.

(1) The County Commissioners may lease, sell, at either public or private
sale, and convey or otherwise dispose of and convey any interest in real estate held by
the County Commissioners and no longer needed for public use. The intent to sell,
dispose of, or convey, except in the case of a conveyance made between the county and
any federal, state or local government, shall be advertised in a newspaper of general
distribution in the county, once a week for 3 successive weeks. The intent to lease real
property shall be advertised at least once in a newspaper of general distribution in
the county.

The County Commissioners may buy at public or private sale or
 accept without consideration any real estate which in their judgment is useful to
 Washington County. However, funds may not be expended from the general fund of

1 the county for the acquisition of real property under this section unless a public

2 hearing has been held on the matter and the proceeds from sales of all existing school

3 facilities, school lands, and other properties presently used for school facilities and

4 titled in the name of the county and/or branch, department or derivative of the county

5 are paid into the "Special School Fund" for school construction and repairs created by

6 the Washington County School Bond Act of 1963.

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 8 October 1, 1998.
