CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Wicomico County Cecil, Kent, and Wicomico Counties - Orphans' Court**  
3 **Judges - Salary Salaries**

4 FOR the purpose of altering the salary of a judge of the Orphans' Court for Wicomico  
5 County; providing that this Act does not apply to the salary or compensation of  
6 an incumbent judge of the Orphans' Court for Wicomico County; and generally  
7 relating to the salary of judges of the Orphans' Court for Wicomico County  
8 salaries of the judges of the orphans' courts for Cecil County, Kent County, and  
9 Wicomico County; providing that this Act does not apply to the salary or  
10 compensation of the incumbent orphans' court judges; and generally relating to  
11 the salaries of the judges of the orphans' courts for Cecil County, Kent County,  
12 and Wicomico County.

2 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
3 MARYLAND, That the Laws of Maryland read as follows:

4 **Article - Estates and Trusts**

5 2-108.

6 *(i) Each of the judges of the Court for Cecil County shall receive an annual*  
7 *compensation of [~~\$3,500~~] \$4,500. Each judge shall also receive an allowance for*  
8 *traveling expenses of \$780 annually, to be paid quarterly by the County*  
9 *Commissioners.*

10 *(p) Each of the judges of the Court for Kent County shall receive an annual*  
11 *compensation of [~~\$2,080~~] \$3,600. Each judge shall also receive an allowance for*  
12 *traveling expenses of \$520 annually, to be paid quarterly by the County*  
13 *Commissioners.*

14 *(w) Each judge of the Court for Wicomico County shall receive an annual*  
15 *salary of [~~\$1,600~~] \$3,200 to be paid quarterly. Each judge shall also receive an annual*  
16 *allowance for traveling expenses of \$1,560 to be paid quarterly.*

17 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III,  
18 Section 35 of the Constitution of Maryland, this Act may not be construed to extend or  
19 apply to the salary or compensation of ~~a judge of the Orphans' Court for Wicomico~~  
20 ~~County~~ *the judges of the orphans' courts for Cecil County, Kent County, and Wicomico*  
21 *County* in office on the effective date of this Act, but the provisions of this Act  
22 concerning the salary or compensation of ~~a judge of the Orphans' Court for Wicomico~~  
23 ~~County~~ *the judges of the orphans' courts for Cecil County, Kent County, and Wicomico*  
24 *County* shall take effect at the beginning of the next following term of office.

25 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
26 October 1, 1998.
