	WHEREAS, The General Assembly enacted the Maryland Revised Uniform Partnership Act (Chapter 654 of the Acts of 1997), as drafted by the National Conference of Commissioners of Uniform State Laws; and		
11	WHEREAS, The revised law provides that a partnership formed before the 0 revision's effective date of July 1, 1998 shall continue to operate under the provisions 1 of the old law until the end of the year 2002, unless the partnership chooses to come 2 under the revised law; and		
	WHEREAS, Chapter 654 repealed the text of the old law from the Annotated Code, which may result in confusion for those partnerships that will remain under the old law prior to the end of 2002; and		
18	WHEREAS, The intent of this Act is to recodify the old Uniform Partnership Act, adjacent to the new Maryland Revised Uniform Partnership Act, solely for the purpose of clarifying the existence, until 2002, of two distinct bodies of law that govern partnerships in the State; and
