- 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 19 MARYLAND, That the Laws of Maryland read as follows:

1 **Article - State Personnel and Pensions** 2 26-201. 3 (a) Except as provided in [subsections (b) and (c)] SUBSECTION (B) of this 4 section, this subtitle applies only to: 5 an employee of the Department of Natural Resources commissioned (1) 6 by the Secretary of Natural Resources as: 7 a Natural Resources police officer; or (i) 8 (ii) a law enforcement officer, other than a Natural Resources police 9 officer; 10 (2) a law enforcement officer employed by the Maryland Investigative 11 Services Unit: 12 a member of the Maryland Transportation Authority Police Force (3) 13 who has the powers granted to a police officer under § 4-208 of the Transportation 14 Article; [or] 15 (4) a deputy sheriff employed by the Baltimore City Sheriff's 16 Department; OR THE STATE FIRE MARSHAL OR A DEPUTY STATE FIRE MARSHAL. 17 (5) 18 (b) This subtitle does not apply to: 19 a Maryland Transportation Authority police officer who transferred (1)20 from the Employees' Retirement System to the Employees' Pension System on or after 21 December 1, 1996[. 22 (c) This subtitle does not apply to]; 23 a deputy sheriff employed by the Baltimore City Sheriff's (2)24 Department who transferred from the Employees' Retirement System to the 25 Employees' Pension System on or after December 1, 1996; OR A STATE FIRE MARSHAL OR DEPUTY STATE FIRE MARSHAL WHO 26 27 TRANSFERRED FROM THE EMPLOYEES' RETIREMENT SYSTEM TO THE EMPLOYEES' 28 PENSION SYSTEM ON OR AFTER DECEMBER 1, 1996. 29 26-202. 30 Except as provided in subsection (b) of this section, an individual described 31 in § 26-201 of this subtitle is a member of the Law Enforcement Officers' Pension 32 System as a condition of employment.

	(b) (1) Subject to paragraph (2) of this subsection, membership in the Law Enforcement Officers' Pension System is optional for an individual described in § 26-201 of this subtitle:
4 5	(i) who was employed by the Department of Natural Resources on July 1, 1990 and who elects membership on or before December 31, 1997;
6 7	(ii) who was employed by the Maryland Investigative Services Unit on June 30, 1995 and who elects membership on or before December 31, 1997;
8 9	(iii) who was employed by the Maryland Transportation Authority on June 30, 1997 and who elects membership on or before December 31, 1997; [or]
10 11	(iv) who was employed by the Baltimore City Sheriff's Department on June 30, 1997 and who elects membership on or before December 31, 1997; OR
	(V) WHO WAS EMPLOYED BY THE OFFICE OF THE STATE FIRE MARSHAL ON JUNE 30, 1998 AND WHO ELECTS MEMBERSHIP ON OR BEFORE DECEMBER 31, 1998.
	(2) To elect to be a member of the Law Enforcement Officers' Pension System, an individual shall file a written application with the State Retirement Agency.
	(3) If an individual does not elect membership during the applicable period specified under paragraph (1) of this subsection, the individual may not become a member of the Law Enforcement Officers' Pension System.

24 25 26	For members who transfer from the Employees' Pension System or the Employees' Retirement System, the Board of Trustees shall transfer to the accumulation fund of the Law Enforcement Officers' Pension System the employer contributions that were made to the Employees' Retirement System and the Employees' Pension System on behalf of those members who transferred, plus the interest earned on those contributions through the date of transfer.
