4 5 6 7	FOR the purpose of authorizing the County Commissioners of Dorchester County to sell a certain parcel of real property to the Dorchester County Family YMCA, Inc. under certain circumstances; and generally relating to the authority of the County Commissioners of Dorchester County to sell real property.

13 14	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

17	(a) This section applies only in Dorchester County.
20	(b) The County Commissioners, in addition to, but not in substitution of, the powers which may have been or may hereafter be granted them, may acquire by lease, purchase, or condemnation, real or leasehold property needed for any public purpose, may erect buildings on the property for the benefit of the County, may sell at

- **HOUSE BILL 1352** 1 public sale any real or leasehold property belonging to the County when in their 2 discretion it is no longer needed for public use, and may execute and acknowledge any 3 and all deeds and other instruments necessary to effect and complete the lease, 4 purchase, or sale of real or leasehold property. 5 Except as provided in paragraph (2) of this subsection, the County (c) (1) 6 Commissioners may sell real or leasehold property without public sale to any 7 municipality or other governmental agency within Dorchester County upon terms 8 and conditions and for consideration, if any, which they consider proper, when in their 9 discretion the property is no longer needed for public use by the County, and may 10 execute and acknowledge any and all deeds and other instruments necessary to effect 11 and complete the sale of the real or leasehold property. 12 (2)The County Commissioners may not sell or lease the riparian rights 13 adjacent to any real or leasehold property that belongs to Dorchester County and is 14 located in the City of Cambridge unless the County Commissioners provide for the 15 public sale or lease under a process that includes the following elements: 16 A public advertisement, in at least one newspaper of general (i) 17 circulation in the County, soliciting sealed bids or proposals; The public opening of sealed bids or proposals; 18 (ii) 19 The rejection of unresponsive or unacceptable bids or proposals; (iii) 20 and 21 (iv) The selection of the bidder or offeror who offers the terms most 22 favorable to the County.
- 23 (3) The County Commissioners may take any and all actions necessary 24 to effectuate and complete the process of competitive bidding under paragraph (2) of 25 this subsection.
- 26 (d) The County Commissioners may lease real or leasehold property belonging 27 to the County, in lieu of sale, to nonprofit organizations upon terms and conditions 28 they deem proper, when in their discretion the real or leasehold property is no longer 29 needed for public use, and to execute and acknowledge any instruments necessary to 30 effect and complete the lease of the property.
- 31 (e) The County Commissioners may sell real or leasehold property or any 32 reversionary interest in that property without a public sale to any volunteer fire 33 company located in the County for use in providing fire, emergency, and supporting 34 services or facilities, upon the terms and conditions and for whatever consideration, if 35 any, which they consider proper when in their discretion the property is no longer 36 needed for public use by the County, and may execute and acknowledge any and all 37 deeds and other instruments necessary to effect and complete the sale of real or 38 leasehold property.

- 13 FROM THENCE RUNNING AND BINDING WITH SCHOOL STREET, NORTH 48 DEGREES
- 14 15 MINUTES WEST, 400 FEET TO SOMERSET AVENUE AND FROM THENCE RUNNING
- 15 AND BINDING WITH SOMERSET AVENUE, SOUTH 41 DEGREES 45 MINUTES WEST, 646
