AND BE IT FURTHER ENACTED, That, pursuant to Article III, 36 Section 35 of the Constitution of Maryland, this Act may not be construed to extend or 37 apply to the salary or compensation of the judges of the Orphans' Court for Baltimore 38 City in office on the effective date of this Act, but the provisions of this Act concerning 39 the salary or compensation of the judges of the Orphans' Court for Baltimore City 40 shall take effect at the beginning of the next following term of office.
