A BILL ENTITLED

1 AN ACT concerning

Maryland	Children's	Health	Program

- 3 FOR the purpose of requiring the Medical Assistance Program to provide certain
- 4 services to certain minors and other individuals who meet certain family income
- 5 standards; providing that in order to qualify for the Program an individual may
- 6 not be covered by or have voluntarily terminated certain employer-based health
- 7 insurance coverage within a certain time period; requiring the Department to
- 8 make certain outreach efforts; providing that Program applications shall be
- 9 made available in a certain manner; requiring the Department to apply for a
- 10 certain waiver, conduct certain studies, and submit certain reports; making
- provisions of this Act severable; and generally relating to the Maryland
- 12 Children's Health Program.

- 3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 4 MARYLAND, That Section(s) 15-103.1 of Article Health General of the Annotated
- 5 Code of Maryland be renumbered to be Section(s) 15-103.2.
- 6 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland 7 read as follows:
- 8 Article Health General
- 9 15-101.
- 10 (a) In this title the following words have the meanings indicated.
- 11 (h) "Program" means the Maryland Medical Assistance Program.
- 12 (i) "Program recipient" means an individual who receives benefits under the
- 13 Program.
- 14 15-103.1.
- 15 (A) SUBJECT TO THE LIMITATIONS OF THE STATE BUDGET, THE PROGRAM
- 16 SHALL PROVIDE COMPREHENSIVE MEDICAL CARE AND OTHER HEALTH CARE
- 17 SERVICES TO AN INDIVIDUAL WHO HAS A FAMILY INCOME AT OR BELOW 200% OF
- 18 THE FEDERAL POVERTY LEVEL AND WHO IS:
- 19 UNDER THE AGE OF 19 YEARS; OR
- 20 (2) PREGNANT OR UP TO 2 MONTHS POSTPARTUM.
- 21 (B) TO QUALIFY AS A PROGRAM RECIPIENT UNDER THIS SECTION, AN
- 22 INDIVIDUAL MAY NOT:
- 23 (1) BE COVERED BY EMPLOYER-BASED HEALTH INSURANCE; OR
- 24 (2) HAVE VOLUNTARILY TERMINATED EMPLOYER-BASED HEALTH
- 25 INSURANCE COVERAGE WITHIN THE PRECEDING 3 MONTHS.
- 26 (C) THE DEPARTMENT SHALL PUBLICIZE THE MARYLAND CHILDREN'S
- 27 HEALTH PROGRAM AND, IN CONJUNCTION WITH THE MARYLAND HEALTH CARE
- 28 FOUNDATION, MAKE OUTREACH EFFORTS THROUGHOUT THE STATE.
- 29 (D) (1) APPLICATIONS TO QUALIFY AS A PROGRAM RECIPIENT UNDER THIS
- 30 SECTION SHALL BE MADE AVAILABLE IN LOCAL HEALTH DEPARTMENTS AND LOCAL
- 31 DEPARTMENTS OF SOCIAL SERVICES.
- 32 (2) TO THE EXTENT POSSIBLE, APPLICATIONS TO QUALIFY AS A
- 33 PROGRAM RECIPIENT UNDER THIS SECTION SHALL BE MADE AVAILABLE IN

- 1 SCHOOLS, DAY CARE CENTERS, LIBRARIES, HEAD START PROGRAMS, AND OTHER 2 APPROPRIATE LOCATIONS.
- 3 (3) APPLICATIONS MAY BE SUBMITTED THROUGH THE MAIL.
- 4 SECTION 3. AND BE IT FURTHER ENACTED, That the Department shall
- 5 apply to the federal Health Care Financing Administration for a waiver and take any
- 6 other steps necessary to secure federal dollars at an enhanced matching rate for
- 7 coverage of pregnant women.
- 8 SECTION 4. AND BE IT FURTHER ENACTED, That the Department of
- 9 Health and Mental Hygiene shall study and report to the Senate Finance Committee,
- 10 the House Environmental Matters Committee, and, in accordance with § 2-1246 of
- 11 the State Government Article, the General Assembly, on or before December 31, 1998,
- 12 on the feasibility and cost-effectiveness of providing family coverage for the families
- 13 of individuals who qualify to receive benefits under § 15-103.1 of the Health -
- 14 General Article.
- 15 SECTION 5. AND BE IT FURTHER ENACTED, That if any provision of this
- 16 Act or the application thereof to any person or circumstance is not approved by the
- 17 federal Health Care Financing Administration, that disapproval does not affect other
- 18 provisions or any other application of this Act which is approved, and for this purpose
- 19 the provisions of this Act are declared severable.
- 20 SECTION 6. AND BE IT FURTHER ENACTED, That this Act shall take
- 21 effect July 1, 1998.
