- 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 14 MARYLAND, That the Laws of Maryland read as follows:

- 17 (a) An action may be maintained in the name of the State or the Board to
- 18 enjoin:
- 19 (1) The unauthorized practice of mortuary science BY AN INDIVIDUAL;
- 20 [or]
- 21 (2) THE UNAUTHORIZED PRACTICE OF MORTUARY SCIENCE BY A
- 22 FOR-PROFIT, NONRELIGIOUS CORPORATE ENTITY; OR
- [(2)] (3) Conduct that constitutes a ground for disciplinary action under
- 24 § 7-315 of this subtitle.
- 25 (b) An action under this section may be brought by:
- 26 (1) The Board;

- 1 (2) The Attorney General; or 2 (3) A State's Attorney. 3 (c) An action under this section shall be brought in the MARYLAND county 4 where the defendant: 5 Resides; [or] (1) CONDUCTS BUSINESS FOR THE INCORPORATED INTEREST; 6 (2) 7 HOLDS A CORPORATE INTEREST IN THE FUNERAL CORPORATE (3) 8 CHARTER; 9 (4) HOLDS OWNERSHIP OF THE FUNERAL CORPORATE CHARTER; 10 (5) IS AN OFFICER OF THE FUNERAL CORPORATE CHARTER; OR 11 [(2)] (6) Engages in the practice of mortuary science.
- 12 (d) Proof of actual damage or proof that a person will sustain damage if an 13 injunction is not granted is not required for an action under this section.
- 14 (e) Criminal prosecution for the unauthorized practice of mortuary science 15 under § 7-501 of this title or disciplinary action under § 7-316 of this subtitle does 16 not prohibit an action to enjoin under this section.
- 17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 18 October 1, 1998.
