BE IT ENACTED BY THE GENERAL ASSEMBLY OF 13 MARYLAND, That Article 70B - Office on Aging of the Annotated Code of Maryland 14 be renamed to be Article 70B - Department of Aging. 15 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland 16 read as follows: 17 **Article 70B - Department of Aging** 18 1. 19 (a) In this article the following words have the meanings indicated. 20 "Area agency on aging" means the local agency designated by the [Office 21 on] DEPARTMENT OF Aging, pursuant to the Older Americans Act of 1965, as 22 amended, within a planning and service area to administer the delivery of a 23 comprehensive and coordinated plan of social and other services and activities for the 24 elderly. 25 (C) "DEPARTMENT" MEANS THE DEPARTMENT OF AGING. [(c)] (D) "Congregate housing services" means services provided in an 26 apartment building that promote independent living and include congregate meals, 28 housekeeping, and personal services for:
- 29 (1) An individual at least 62 years old who has temporary or periodic
- 30 difficulty with one or more essential activities of daily living, such as feeding, bathing,
- 31 grooming, dressing, or transferring; and
- 32 (2) The spouse of an individual described in paragraph (1) of this
- 33 subsection who is at least 55 years old and who has temporary or periodic difficulty
- 34 with one or more essential activities of daily living, such as feeding, bathing,
- 35 grooming, dressing, or transferring.

- 1 [(d)] (E) "Interagency Committee on Aging Services" means the body
- 2 designated in this article to oversee the coordination and consolidation of services for
- 3 the elderly in this State.
- 4 [(e)] (F) "Planning and service area" means a subdivision or subdivisions of
- 5 the State designated by the [Office on] DEPARTMENT OF Aging, pursuant to the
- 6 Older Americans Act of 1965, as amended, for the planning and administration of
- 7 social, health, and other services for the elderly.
- 8 (G) "SECRETARY" MEANS THE SECRETARY OF AGING.

- 10 (a) The Office on Aging is created as part of the Executive Department. The
- 11 Office consists of a Director on Aging and the Commission on Aging.
- 12 (b) The Director on Aging shall be appointed by and serve at the pleasure of
- 13 the Governor and be directly responsible to him. The Director is responsible for the
- 14 operation of the Office and shall establish guidelines and procedures to promote the
- 15 orderly and efficient administration of the Office. He shall receive the salary provided
- 16 in the State budget.
- 17 (c) The Office shall have the assistants, consultants, and employees provided
- 18 in the State budget.]

- 20 (A) THERE IS A DEPARTMENT OF AGING, ESTABLISHED AS A PRINCIPAL
- 21 DEPARTMENT OF THE STATE GOVERNMENT.
- 22 (B) THE HEAD OF THE DEPARTMENT IS THE SECRETARY OF AGING, WHO
- 23 SHALL BE APPOINTED BY THE GOVERNOR WITH THE ADVICE AND CONSENT OF THE
- 24 SENATE.
- 25 (C) (1) THE SECRETARY SERVES AT THE PLEASURE OF THE GOVERNOR AND
- 26 IS RESPONSIBLE DIRECTLY TO THE GOVERNOR. THE SECRETARY SHALL ADVISE THE
- 27 GOVERNOR ON ALL MATTERS ASSIGNED TO THE DEPARTMENT AND IS RESPONSIBLE
- 28 FOR CARRYING OUT THE GOVERNOR'S POLICIES ON THESE MATTERS.
- 29 (2) THE SECRETARY IS RESPONSIBLE FOR THE OPERATION OF THE
- 30 DEPARTMENT AND SHALL ESTABLISH GUIDELINES AND PROCEDURES TO PROMOTE
- 31 THE ORDERLY AND EFFICIENT OPERATION OF THE DEPARTMENT. THE SECRETARY
- 32 MAY ESTABLISH, REORGANIZE, OR ABOLISH AREAS OF RESPONSIBILITY IN THE

AND BE IT FURTHER ENACTED, That on or before July 1, 1999, the Department of Aging shall report to the Governor and, in accordance with § 2-1246 of the State Government Article, the General Assembly on a strategic plan to 8 prepare Maryland for the growth of the elderly population in the State over the next 9 30 years. The report shall include recommendations for:
