- 25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 26 MARYLAND, That the Laws of Maryland read as follows:

1 Article 2B - Alcoholic Beverages 2 7-101. 3 (b) (1) Subject to subsection (a) of this section, a special Class C beer (i) 4 license or a special Class C beer and wine license entitles the holder to exercise any of 5 the privileges conferred by the respective classes of licenses for the use of any person 6 holding any bona fide entertainment conducted by any club, society or association at 7 the place described in the license, for a period not exceeding seven consecutive days 8 from the effective date thereof. 9 (ii) The fee is \$5 per day. 10 (3) In Baltimore City the fee is [\$15] \$25 per day. 11 (d) (3) In Baltimore City: 12 The holder of a Class C special beer, wine and liquor license 13 may purchase beer and light wine from a wholesale dealer. 14 (ii) The fee is [\$30] \$50 per day. 15 8-801. 16 (c) The Board may issue a special festival license for participation in a beer 17 festival to be held on Class B retail licensed premises or on nonlicensed premises 18 located in Baltimore City. 19 (h) The license fee is \$50 PER DAY. 20 10-503. 21 (d) (1) This subsection applies only in Baltimore City. 22 A transfer of any license may only be made as authorized in (2)23 subsection (a) of this section if the Board has presented to it a receipt or certificate 24 from the Director of Finance showing there are no unpaid taxes on the merchandise, 25 fixtures, and stock of the transferor due to the City of Baltimore or the State of 26 Maryland. 27 SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH, THE FEE (3) (I) 28 FOR TRANSFER OR ASSIGNMENT OF A LICENSE IS \$100 IN ADDITION TO THE COST OF 29 PUBLICATION AND NOTICE AND ANY HEARING FEES REQUIRED. A CLASS C LICENSEE MAY TRANSFER OR ASSIGN ONE LICENSE 30 (II)31 DURING A LICENSE YEAR WITHOUT PAYING A FEE. 32 16-410.

- 1 (2) THE BOARD SHALL CHARGE FEES FOR THE PRODUCTION AND 2 SERVICE OF SUMMONSES AND HEARING NOTICES. THOSE FEES ARE:
- 3 (I) \$25 FOR THE PRODUCTION OF HEARING NOTICES OR FOR
- 4 SUMMONSES REQUESTED BY PARTIES APPEARING BEFORE THE BOARD;
- 5 (II) \$5 FOR EACH ADDRESS SERVED IF THE SERVICE IS BY MAIL
- 6 AND THE ADDRESS IS PROVIDED TO THE BOARD; OR
- 7 (III) \$25 FOR EACH ADDRESS SERVED IF SERVICE IS BY AN 8 EMPLOYEE OF THE BOARD.
- 9 (3) IN ADDITION TO ANY OTHER FINES, PENALTIES, OR COSTS THAT MAY
- 10 BE IMPOSED BY THE BOARD, THE BOARD MAY ASSESS THE FEE FOR THE
- 11 PRODUCTION AND SERVICE OF SUMMONSES AND HEARING NOTICES AND A \$100
- 12 ADMINISTRATIVE HEARING FEE FOR ANY LICENSEE WHO THE BOARD IS CHARGING
- 13 WITH VIOLATION OF ANY LAW, STATUTE, RULE, OR REGULATION CONCERNING THE
- 14 SALE OF ALCOHOLIC BEVERAGES OR WHO IS REQUESTING A TRANSFER, EXPANSION,
- 15 OR NEW LICENSE.
- 16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an
- 17 emergency measure, is necessary for the immediate preservation of the public health
- 18 and safety, has been passed by a yea and nay vote supported by three-fifths of all the
- 19 members elected to each of the two Houses of the General Assembly, and shall take
- 20 effect from the date it is enacted.
