8 FOR the purpose of authorizing the creation of a State Debt in the amount of Four  
9    Hundred ~~Nineteen Million, Eight Hundred Twenty-Four Seven Million, One~~  
10   Hundred Two Thousand Dollars (~~\$419,824,000~~) (\$407,102,000), the proceeds to  
11   be used for certain necessary building, construction, demolition, planning,  
12   renovation, conversion, replacement, and capital equipment purchases of this  
13   State, and for acquiring certain real estate in connection therewith, and for  
14   grants to certain subdivisions and other organizations for certain purposes,  
15   subject to the requirement that certain grantees provide certain matching funds  
16   of a certain type by a certain date; providing generally for the issuance and sale  
17   of bonds evidencing the loan; providing for certain unexpended appropriations  
18   in prior Capital Budgets and Bond Acts to be expended for other public projects;  
19   altering certain requirements for certain programs in prior Capital Budgets;  
20   providing that the authorizations of State Debt in certain prior Capital Budgets  
21   and Bond Acts be reduced by certain amounts; and generally relating to the  
22   financing of certain capital projects.
