- 20 A PERSON MAY NOT USE ELECTRONIC MAIL: (B)

- 1 (1) FOR AN ANONYMOUS COMMUNICATION IF IN A MANNER
- 2 REASONABLY TO BE EXPECTED TO ANNOY, ABUSE, TORMENT, HARASS, OR
- 3 EMBARRASS ONE OR MORE PERSONS;
- 4 (2) FOR REPEATED COMMUNICATIONS, IF WITH INTENT TO ANNOY,
- 5 ABUSE, TORMENT, HARASS, OR EMBARRASS ONE OR MORE PERSONS; OR
- 6 (3) FOR ANY COMMENT, REQUEST, SUGGESTION, OR PROPOSAL WHICH 7 IS OBSCENE, LEWD, LASCIVIOUS, FILTHY, OR INDECENT, IF WITH INTENT TO ANNOY,
- 8 ABUSE, TORMENT, HARASS, OR EMBARRASS ONE OR MORE PERSONS.
- 9 (C) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A MISDEMEANOR
- 10 AND ON CONVICTION IS SUBJECT TO A FINE OF NOT MORE THAN \$500 OR TO
- 11 IMPRISONMENT FOR NOT MORE THAN 3 YEARS OR BOTH.
