CHAPTER _____

1 AN ACT concerning

2 **Kent County - Alcoholic Beverages - Licenses and Disciplinary Proceedings**

3 FOR the purpose of requiring a restaurant in Kent County for which a Class B beer,
4 wine and liquor license is sought to meet a certain requirement concerning food
5 sales and alcoholic beverages sales; prohibiting in Kent County a finding of
6 probation before judgment from barring a proceeding brought by the Board of
7 License Commissioners against a licensee for an alleged violation of the
8 alcoholic beverages laws; and generally relating to alcoholic beverages in Kent
9 County.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
21 MARYLAND, That the Laws of Maryland read as follows:

Article 2B - Alcoholic Beverages

1 5-201.

2 (p) (1) This subsection applies only in Kent County.

3 (2) The annual license fee is \$1,000.

4 (3) Any restaurant qualifying under § 6-201(p)(2)(ii) AND (III) of this
5 article may apply to the Board of License Commissioners for a special Class B beer
6 and light wine license.

7 6-201.

8 (p) (1) (i) This subsection applies only in Kent County.

9 (2) (ii) To qualify for licensure under this subsection, the restaurant
10 shall:

11 1. Be fully equipped with a proper and adequate dining
12 room;

13 2. Have sufficient facilities for preparing and serving meals
14 to the public; and

15 3. Be approved by the Board.

16 (iii) When operating under this license, a holder's average daily
17 receipts from the sale of food shall comprise at least 60 percent of the average daily
18 receipts of the business.

19 12-108.

20 (f) (1) This subsection applies in the following jurisdictions:

21 (i) Dorchester County;

22 (ii) Howard County;

23 (III) KENT COUNTY; and

24 [(iii)] (IV) Montgomery County.

25 (2) The granting of probation before judgment to a licensee or employee
26 of the licensee for violating subsection (a) of this section does not bar the Board of
27 License Commissioners from proceeding administratively against the licensee for the
28 violation.

29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
30 October 1, 1998.
