6 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, 7 Section 35 of the Constitution of Maryland, this Act may not be construed to extend or 8 apply to the salary or compensation of the Sheriff of Baltimore City in office on the 9 effective date of this Act, but the provisions of this Act concerning the salary or 10 compensation of the Sheriff of Baltimore City shall take effect at the beginning of the 11 next following term of office.

12 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 13 July 1, 1998.
