## A BILL ENTITLED

## 1 AN ACT concerning

## 2 Creation of a State Debt - Maryland General Hospital

- 3 FOR the purpose of authorizing the creation of a State Debt not to exceed \$480,000,
- the proceeds to be used as a grant to the Board of Directors of Maryland General 4
- 5 Hospital, Inc. for certain acquisition, development, or improvement purposes;
- 6 providing for disbursement of the loan proceeds, subject to a requirement that
- 7 the grantee provide and expend a matching fund; and providing generally for
- the issuance and sale of bonds evidencing the loan. 8

## 9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 10 MARYLAND, That:
- 11 The Board of Public Works may borrow money and incur indebtedness on
- 12 behalf of the State of Maryland through a State loan to be known as the Maryland
- 13 General Hospital Project Loan of 1998 in a total principal amount equal to the lesser
- 14 of (i) \$480,000 or (ii) the amount of the matching fund provided in accordance with
- 15 Section 1(5) below. This loan shall be evidenced by the issuance, sale, and delivery of
- 16 State general obligation bonds authorized by a resolution of the Board of Public
- 17 Works and issued, sold, and delivered in accordance with §§ 8-117 through 8-124 of
- 18 the State Finance and Procurement Article and Article 31, § 22 of the Code.
- 19 The bonds to evidence this loan or installments of this loan may be sold as
- 20 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 21 § 8-122 of the State Finance and Procurement Article.
- 22 The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 23 and first shall be applied to the payment of the expenses of issuing, selling, and
- 24 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 25 shall be credited on the books of the Comptroller and expended, on approval by the
- 26 Board of Public Works, for the following public purposes, including any applicable
- 27 architects' and engineers' fees: as a grant to the Board of Directors of Maryland
- 28 General Hospital, Inc. (referred to hereafter in this Act as "the grantee") for the repair
- 29 and renovation of the inpatient psychiatric and geropsychiatric facility of the
- 30 Hospital, thereby improving the psychiatric services offered to the medically
- 31 underserved citizens of Baltimore City.

- 1 (4) An annual State tax is imposed on all assessable property in the State in 2 rate and amount sufficient to pay the principal of and interest on the bonds, as and 3 when due and until paid in full. The principal shall be discharged within 15 years 4 after the date of issuance of the bonds.
- 5 (5) Prior to the payment of any funds under the provisions of this Act for the 6 purposes set forth in Section 1(3) above, the grantee shall provide and expend a
- $7\,$  matching fund. No part of the grantee's matching fund may be provided, either
- 8 directly or indirectly, from funds of the State, whether appropriated or
- 9 unappropriated. No part of the fund may consist of real property or in kind
- 10 contributions. The matching fund may consist of funds expended prior to the effective
- 11 date of this Act. In case of any dispute as to the amount of the matching fund or what
- 12 money or assets may qualify as matching funds, the Board of Public Works shall
- 13 determine the matter and the Board's decision is final. The grantee has until June 1,
- 14 2000, to present evidence satisfactory to the Board of Public Works that a matching
- 15 fund will be provided. If satisfactory evidence is presented, the Board shall certify this
- 16 fact and the amount of the matching fund to the State Treasurer, and the proceeds of
- 17 the loan equal to the amount of the matching fund shall be expended for the purposes
- 18 provided in this Act. Any amount of the loan in excess of the amount of the matching
- 19 fund certified by the Board of Public Works shall be canceled and be of no further
- 20 effect.
- 21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 22 June 1, 1998.
