- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, That the Laws of Maryland read as follows:

- 18 (a) To qualify for a real estate salesperson license, an applicant shall be an
- 19 individual who meets the requirements of this section.
- 20 (b) An applicant shall be of good character and reputation.
- 21 (c) An applicant shall be at least 18 years old.
- 22 (d) An applicant shall have completed successfully:
- 23 (1) a basic course in real estate approved by the Commission THAT DOES
- 24 NOT REQUIRE MORE THAN 45 CLOCK HOURS OF CLASSROOM INSTRUCTION; or
- 25 (2) if approved by the Commission as an alternative, courses in real 26 estate subjects in any college.

5	(f) An applicant shall obtain, from a licensed real estate broker, a commitment providing that the applicant shall become affiliated with the licensed real estate broker as a real estate salesperson on the granting of a real estate salesperson license to the applicant.					
	(g) An applicant shall meet any other requirement that the Commission establishes to ensure that only individuals who are professionally competent and of good character and reputation are licensed.

	(i) in the license term that begins in 1992, at least 12 clock hours of continuing education instruction, as provided in this section, during each 2-year license term; and					
	(ii) in and after the license term that begins in 1996, at least 15 clock hours of continuing education instruction, as provided in this section, during the preceding 2-year term.					
21	(2) Notwithstanding paragraph (1) of this [subsection, if a license is granted to a licensee during the 2nd year of a license term, the licensee may renew the license for the next full term without complying with the continuing education requirements of this section.] SUBSECTION:
