CHAPTER\_\_\_\_\_

1 AN ACT concerning

2 **Care of Mistreated Animals - Accompanying Veterinarians**

3 FOR the purpose of allowing licensed veterinarians of the State to accompany police  
4 officers, animal humane society officials, and certain public officials when  
5 entering any place where certain animals are impounded or confined, in order to  
6 care for or remove the animals, without being held liable for the entry.

7 BY repealing and reenacting, with amendments,  
8 Article 27 - Crimes and Punishments  
9 Section 67  
10 Annotated Code of Maryland  
11 (1996 Replacement Volume and 1997 Supplement)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article 27 - Crimes and Punishments**

15 67.

16 If the owner or custodian of an animal is convicted of any act of animal cruelty,  
17 the judge may use his own discretion in ordering the removal of that animal or  
18 animals for their protection at the time of conviction. Whenever it becomes necessary,  
19 in order to protect any animal from neglect or cruelty, any officer or authorized agent  
20 of an animal humane society or any police officer or other public officials charged with  
21 the protection of animals may take possession of it, except that animals in the  
22 possession of medical and scientific research facilities may not be removed therefrom  
23 without the prior review and recommendation of the Department of Health and

1 Mental Hygiene, Division of Veterinary Medicine. The Department of Health and  
2 Mental Hygiene shall conduct an investigation within 24 hours of the receipt of a  
3 complaint and shall, within 24 hours of the investigation, report to the State's  
4 Attorney of the county in which the facilities are situated. If an animal is impounded,  
5 yarded or confined and continues without necessary food, water or proper attention,  
6 or is cruelly treated or neglected, any officer or authorized agent of an animal humane  
7 society or any police officer or other public officials charged with the protection of  
8 animals, OR ANY LICENSED VETERINARIAN OF THE STATE ASKED TO ACCOMPANY  
9 THEM, may enter into and upon any place in which the animal is impounded, yarded  
10 or confined and supply it with necessary food, water and attention so long as it there  
11 remains, or, if necessary, for the health of the animal, may remove the animal, and not  
12 be liable to any action for that entry. In all cases the owner or custodian of that  
13 animal shall be notified of that action and any administrative remedies which may be  
14 available by the person taking possession of the animal. The owner or custodian may  
15 file within ten days, if no administrative remedy is available, a petition for return of  
16 the animal in the District Court of the county in which the removal occurred. If the  
17 owner or custodian is notified and fails to file the petition within the time prescribed,  
18 or if the owner or custodian is unknown and cannot with reasonable effort be  
19 ascertained for a period of 20 days, the animal shall be held to be an estray and be  
20 dealt with as such, provided, however, that nothing in this section shall be construed  
21 as permitting the entry into a private dwelling or as permitting the taking of a farm  
22 animal without prior recommendation of a licensed veterinarian OF THE STATE. In  
23 Baltimore County, the provisions of this section shall be enforced by the Baltimore  
24 County Bureau of Animal Control or by an organization approved by the Baltimore  
25 County government.

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
27 October 1, 1998.
