4 vehicle registration plates commemorating the life of Martin Luther King, Jr.;

- 5 specifying the classes of vehicles eligible for the special registration plates;
- 6 requiring, subject to certain exceptions, an applicant for the special registration
- 7 plates to pay the fee established by the Administration; requiring the fee to be
- 8 set at a level that enables the Administration to recover the costs of issuing the

9 special registration plates; providing for the design of the special registration

10 plates; requiring the Administration to adopt certain regulations to govern the

11 issuance of the special registration plates; and generally relating to Martin

12 Luther King, Jr. commemorative registration plates.

# (A) THE ADMINISTRATION SHALL ISSUE IN ACCORDANCE WITH THIS SECTION SPECIAL ORIGINAL OR SUBSTITUTE REGISTRATION PLATES COMMEMORATING THE LIFE OF MARTIN LUTHER KING, JR.

(B) THE OWNER OF A VEHICLE, OR A LESSEE OF THE VEHICLE UNDER A
LEASE NOT INTENDED AS SECURITY, OR A DIRECTOR, OFFICER, EMPLOYEE, OR
PARTNER OF A BUSINESS ENTITY THAT OWNS THE VEHICLE CONSIDERED ELIGIBLE
BY THE ADMINISTRATION MAY APPLY TO THE ADMINISTRATION FOR THE

ASSIGNMENT OF A COMMEMORATIVE REGISTRATION PLATE UNDER THIS SECTION IF
 THE VEHICLE IS INCLUDED IN ONE OF THE FOLLOWING CLASSES:

4 (2) A CLASS B (FOR HIRE) VEHICLE;

16 (3) NO PORTION OF THE FEE MAY BE CREDITED TO THE GASOLINE AND
17 MOTOR VEHICLE REVENUE ACCOUNT FOR DISTRIBUTION UNDER § 8-403 OR § 8-404

19 (D) THE ADDITIONAL FEE REQUIRED UNDER SUBSECTION (C)(1) OF THIS
20 SECTION IS NOT REQUIRED FOR SPECIAL REGISTRATION OF A VEHICLE THAT IS
21 EXEMPT UNDER § 13-903 OF THIS TITLE, OR A VEHICLE WITH A SPECIAL
22 REGISTRATION PLATE RECOGNIZING:

23 (1) THE MARYLAND NATIONAL GUARD; OR

24 (2) A VOLUNTEER FIRE DEPARTMENT, VOLUNTEER RESCUE SQUAD, OR 25 VOLUNTEER AMBULANCE COMPANY IN THE STATE.

26(E)(1)A SPECIAL REGISTRATION NUMBER AS SPECIFIED BY THE27ADMINISTRATION AND ASSIGNED UNDER THIS SECTION MAY CONSIST OF:

28 (I) ANY COMBINATION OF:

29 1. LETTERS; AND

30 2. NUMERALS; AND

31(II)ANY DESIGN APPROVED BY THE ADMINISTRATION THAT32COMMEMORATES MARTIN LUTHER KING, JR.

1 (2) A SPECIAL REGISTRATION NUMBER OR DESIGN ASSIGNED UNDER 2 THIS SECTION SHALL BE DISPLAYED ON THE REGISTRATION PLATES FOR THE 3 VEHICLE.

4 (F) THE ADMINISTRATION SHALL ADOPT REGULATIONS NOT INCONSISTENT
5 WITH THE MARYLAND VEHICLE LAW TO GOVERN THE ISSUANCE OF SPECIAL
6 REGISTRATION PLATES UNDER THIS SECTION.

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect8 October 1, 1998.
