CHAPTER _____

1 AN ACT concerning

2 **Militia - Honor Guard at Burial Service of Veteran**

3 FOR the purpose of authorizing the Adjutant General to organize an honor guard
4 from the National Guard or the organized militia to attend the burial services of
5 certain veterans under certain circumstances; authorizing the Adjutant General
6 to request an honor guard from a certain veterans' organization to attend the
7 burial service of a certain veteran under certain circumstances; providing for the
8 composition of the honor guard; requiring the Governor to adopt regulations to
9 implement this Act; providing the Adjutant General with the funds to
10 compensate the honor guards and a certain staff at a certain rate; and generally
11 relating to militia and an honor guard at the burial service of a certain veteran.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
18 MARYLAND, That the Laws of Maryland read as follows:

1 **Article 65 - Militia**

3 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS
4 INDICATED.5 (2) "NATIONAL GUARD" MEANS THE ARMY NATIONAL GUARD, THE AIR
6 NATIONAL GUARD, OR THE MARYLAND DEFENSE FORCE.

7 (3) "VETERAN" MEANS AN INDIVIDUAL WHO:

8 (I) SERVED ON ACTIVE DUTY IN THE ARMED FORCES OF THE
9 UNITED STATES DURING A TIME OF CONFLICT, AS DEFINED BY THE DEPARTMENT OF
10 DEFENSE; OR11 (II) SERVED AS A MEMBER OF THE NATIONAL GUARD AND DIED
12 WHILE A MEMBER OF THE NATIONAL GUARD.13 (B) (1) THE ADJUTANT GENERAL MAY ORGANIZE A UNIFORMED HONOR
14 GUARD FROM THE NATIONAL GUARD OR THE ORGANIZED MILITIA TO ATTEND THE
15 BURIAL SERVICE OF A DECEASED VETERAN IF:16 (I) THE COMMANDER OF AN ACCREDITED VETERANS'
17 ORGANIZATION OR A FRIEND OR RELATIVE OF THE DECEASED VETERAN REQUESTS
18 AN HONOR GUARD TO ATTEND THE BURIAL SERVICE;19 (II) A UNIFORMED HONOR GUARD FROM THE ACTIVE ARMED
20 FORCES OR VETERANS' ORGANIZATION IS NOT AVAILABLE; AND21 (III) THE ADJUTANT GENERAL DETERMINES THAT PROVISION OF
22 AN HONOR GUARD WILL NOT HAVE A DETRIMENTAL EFFECT ON THE READINESS OF
23 THE NATIONAL GUARD IN THE EVENT OF A STATE OR FEDERAL EMERGENCY OR THE
24 EMPLOYMENT OF A NATIONAL GUARD MEMBER.25 (2) IF AN HONOR GUARD FROM THE ACTIVE ARMED FORCES IS NOT
26 AVAILABLE, THE ADJUTANT GENERAL MAY REQUEST AN HONOR GUARD FROM A
27 VETERANS' ORGANIZATION TO ATTEND THE BURIAL SERVICE OF A DECEASED
28 VETERAN.29 (C) THE HONOR GUARD SHALL PERFORM AS A MILITARY HONOR GUARD AND
30 A SQUAD TO FIRE VOLLEYS AT THE BURIAL SERVICE OF A DECEASED VETERAN.31 (D) THE HONOR GUARD SHALL CONSIST OF NOT MORE THAN FIVE RIFLE
32 BEARERS AND A BUGLER.33 (E) THE ADJUTANT GENERAL SHALL ADOPT REGULATIONS TO IMPLEMENT
34 THIS SECTION.35 (F) (1) THE GOVERNOR SHALL PROVIDE, IN THE ANNUAL BUDGET,
36 SUFFICIENT FUNDS FOR THE COMPENSATION OF:

1 (I) THE HONOR GUARDS; AND

2 (II) THE NATIONAL GUARD PERSONNEL WHO COORDINATE HONOR
3 GUARD PARTICIPATION IN THE BURIAL SERVICES.

4 (2) COMPENSATION OF HONOR GUARD MEMBERS SHALL BE AT THE
5 RATE OF 75% OF 1 DAY'S BASIC PAY; HOWEVER, THE COMPENSATION MAY NOT BE
6 LESS THAN \$30 NOR MORE THAN \$60 PER DAY, PLUS OTHER EXPENSES INCURRED TO
7 PARTICIPATE IN THE BURIAL SERVICE OF A DECEASED VETERAN.

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
9 October 1, 1998.
