BY repealing and reenacting, with amendments, 8 Article 2B - Alcoholic Beverages 10 Section 8-211 11 Annotated Code of Maryland 12 (1996 Replacement Volume and 1997 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 13 14 MARYLAND, That the Laws of Maryland read as follows: 15 **Article 2B - Alcoholic Beverages** 16 8-211. 17 The provisions of this section apply only in Frederick County. (a) 18 A license for the sale of alcoholic beverages authorized by this article may 19 not be issued for any place of business located in any of the following election districts: 20 Catoctin (6th), 21 Hauvers (10th), 22 Jackson (16th), 23 Linganore (19th),

	(c) Class A, B, and C licenses for the sale of beer only, as authorized by this article, shall be issued for places of business located in any of the following election districts:
5	Middletown (3rd),
6	[Jefferson (14th),]
7	Johnsville (17th), and
8	Burkittsville (22nd).
	(d) Class A, B, and C licenses for the sale of beer and light wine and A, B, and C licenses for the sale of beer, wine and liquor, as authorized by this article, shall be issued for places of business located in any of the following election districts:

- 1 (e) Class C licenses for the sale of beer, wine and liquor, as authorized by this 2 article, shall be issued for places of business located in the 3rd election district.

 3 (f) Notwithstanding any other provisions of this section wine may be sold as 4 provided under a winery license, a limited winery license, or a Class A light wine
- 6 (g) (1) The restrictions in this section and in § 7-101(g) of this article do not 7 apply to licenses issued pursuant to this subsection.
- 8 (2) The following entities may obtain a license for the sale of beer, wine 9 and liquor:
- 10 (i) Middletown Volunteer Fire Company;
- 11 (ii) Wolfsville Volunteer Fire Company;
- 12 (iii) Jefferson Volunteer Fire Company; and
- 13 (iv) Myersville Volunteer Fire Company.
- 14 (3) All net proceeds from the sale of alcoholic beverages for the entities
- 15 listed in paragraph (2) of this subsection shall be used solely to purchase fire and
- 16 rescue equipment, for operating expenses, and for constructing and maintaining the
- 17 buildings which house the emergency equipment.

- 18 SECTION 2. AND BE IT FURTHER ENACTED, That before this Act becomes
- 19 legally effective it shall first be submitted to a referendum of the legally qualified
- 20 voters of the 14th Election District of Frederick County at the general election to be
- 21 held in November of 1998. The cost of the special election, if any, shall be paid by the
- 22 Board of County Commissioners. The Board of County Commissioners and the Board
- 23 of Supervisors of Elections of Frederick County shall do those things necessary and
- 24 proper to provide for and hold the referendum required by this section. If a majority of
- 25 the votes cast on the question are "For the referred law" the provisions of this Act
- 26 shall become effective on the 30th day following the official canvass of votes for the
- 27 referendum. If a majority of the votes cast on the question are "Against the referred
- 28 law" the provisions of this Act are of no effect and null and void.
- 29 SECTION 3. AND BE IT FURTHER ENACTED, That, subject to the provisions
- 30 of Section 2 of this Act and for the sole purpose of providing for the referendum
- 31 required by Section 2 of this Act, this Act shall take effect October 1, 1998.
