8 the Maryland Public Ethics Law.

9 WHEREAS, When the Maryland Public Ethics Law was enacted in 1979, the 10 General Assembly codified the ethics provisions of the House and Senate Rules; and

WHEREAS, For policy reasons, the General Assembly followed the text of theHouse and Senate Rules provisions almost verbatim, making only stylistic changes;and

WHEREAS, Since that time, various changes have been made to the GeneralAssembly portion of the Maryland Public Ethics Law; and

WHEREAS, The need has arisen to make a careful examination of the Maryland
Public Ethics Law as it relates to the General Assembly and its members; now,
