2 3 4	Maryland Higher Education - Maryland Charter for Higher Education Governance, Coordination, and Funding of the University System of Maryland
5	FOR the purpose of establishing a task force to study the governance, coordination,
6	and funding of the University System of Maryland; providing for the

- 7 membership of the task force; providing for certain notice procedures for 8 meetings of the task force; providing for a certain report; and generally relating
- 9 to a task force to study the governance, coordination, and funding of the
- 10 University System of Maryland.
- WHEREAS, Nearly 10 years have passed since the General Assembly and 11
- 12 Governor created the Maryland Charter for Higher Education; and
- 13 WHEREAS, A major State recession in the early 1990's dramatically affected
- 14 funding for higher education and only now, despite the strong efforts of the Governor
- 15 and General Assembly for four years, is public higher education funding back to its
- 16 pre-recession level and a more stable funding source is necessary to meet the goals of
- 17 the Charter; and
- 18 WHEREAS, The duties and potential overlap of the Maryland Higher Education
- 19 Commission, the University System of Maryland Board of Regents, and the
- presidents of the constituent institutions of the University System, deserve review in
- 21 light of the experience gained since 1988 and the State's continuing interest in a
- 22 public higher education system with the accountability necessary to achieve a highly
- 23 skilled and productive workforce; and
- WHEREAS, An examination of the State's funding priorities to broaden and 24
- 25 sustain the national reputation of public higher education in Maryland, including its
- 26 flagship university, historically Black institutions, research institutions, and the
- 27 comprehensive institutions, should be undertaken; and
- 28 WHEREAS, In order to meet the changing role of higher education for Maryland
- 29 citizens, it is necessary to review the State's fiscal and licensure policies towards
- 30 emerging electronic education, distance education, and other nontraditional delivery
- 31 mechanisms of instruction and training in both credit and noncredit, profit and
- 32 nonprofit, public and private colleges and universities; and

- 1 WHEREAS, The University System of Maryland was founded in order to reduce
- 2 unnecessary expenditures and duplication and to enhance both management
- 3 accountability and academic achievement; and
- WHEREAS, The University System of Maryland today costs more than \$10
- 5 million per year and potentially duplicates many of the functions existing within its
- 6 constituent institutions, and may require changes to enhance the ability of the
- 7 institutions to respond efficiently and effectively to the needs of the workforce in a
- 8 high technology environment; and
- 9 WHEREAS, Within this context of changing technology and educational needs it
- 10 is critical to review those functions and costs of the Maryland Higher Education
- 11 Commission and the University System of Maryland; and
- WHEREAS, There is a marked disparity in funding per full-time equivalent
- 13 undergraduate students among the University System of Maryland institutions as
- 14 well as between University System of Maryland institutions and other public
- 15 comprehensive institutions outside the University System of Maryland; and
- WHEREAS, Subsequent to the formation of the University System of Maryland,
- 17 two research institutions have been established, general fund support for University
- 18 College and a revised community college formula have been enacted, and student
- 19 financial aid programs have been enhanced without major funding increases to other
- 20 undergraduate institutions; and
- 21 WHEREAS, The system and base level funding required to afford all Maryland
- 22 undergraduate students a quality education should be reviewed; and
- 23 WHEREAS, It is necessary that each of our public universities are held
- 24 accountable to students, parents, taxpayers, and those who make educational policy;
- 25 and
- 26 WHEREAS, Streamlining the organizational chart of the University System of
- 27 Maryland may result in greater efficiency, effectiveness, and accountability; now,
- 28 therefore, be it
- 29 RESOLVED BY THE GENERAL ASSEMBLY OF MARYLAND, That the
- 30 General Assembly and Governor establish a task force to study the governance,
- 31 coordination, and funding of the University System of Maryland; and be it further
- 32 RESOLVED, That the task force consider methods to increase the prominence of
- 33 the University System of Maryland's constituent institutions nationally and
- 34 internationally, the efficiency of the delivery of higher education services to Maryland
- 35 citizens, and other issues related generally to governance, coordination, and funding
- 36 of the University System of Maryland; and be it further
- 37 RESOLVED, That the task force be composed of:
- 38 (1) Three members of the Senate of Maryland, appointed by the
- 39 President of the Senate;

1 (2) Three members of the House of Delegates, appointed by the Speaker 2 of the House: 3 (3) The Secretary of Higher Education; The President of the University of Maryland, College Park or a 4 (4) designee of that President; The President of Towson University or a designee of that President; 6 (5) 7 (6)The President of the University of Maryland Eastern Shore or a 8 designee of that President; 9 (7) The President of Frostburg State University or a designee of that 10 President; 11 (8)One member of the University System of Maryland Board of Regents; 12 Two members of the Board of Visitors of the constituent institutions 13 of the University System of Maryland, appointed jointly by the President of the 14 Senate and the Speaker of the House; 15 One representative of the American Association of State Colleges and (10)16 Universities: 17 (11)One representative of the National Association of State Universities 18 and Land Grant Colleges; and 19 (12)Five members of the public appointed by the Governor; and be it 20 further 21 RESOLVED, That the chairman of the task force shall be appointed by the 22 Governor after consultation with the President of the Senate and the Speaker of the 23 House; and be it further 24 RESOLVED, That the task force shall solicit the views of the Board of Regents of 25 the University System of Maryland, the members of the Board of Visitors of the 26 constituent institutions of the University System of Maryland, the members of the 27 Maryland Higher Education Commission, and leading national experts in higher 28 education; and be it further 29 RESOLVED, That the task force report its findings and recommendations to the 30 General Assembly and Governor and, in accordance with § 2-1246 of the State 31 Government Article, to the General Assembly by October 15, 1998; and be it further 32 RESOLVED, That staff for the task force shall be provided by the Department of 33 Legislative Services, and that notice of each meeting of the task force be made public 34 by delivering a copy of the meeting notice to the Legislative Information Officer, Room 35 B-6, Department of Legislative Services, Legislative Services Building, 90 State 36 Circle, Annapolis, Maryland 21401-1991. The notice should be delivered no later than

- 1 Tuesday afternoon at 4:00 p.m. for inclusion in the weekly Hearing Schedule; and be 2 it further
- RESOLVED, That copies of this Resolution be forwarded by the Department of Legislative Services to the Honorable Parris N. Glendening, Governor of Maryland;
