SENATE JOINT RESOLUTION

- 1 A Senate Joint Resolution concerning
- 2 Prince George's County Bishop James R. Peebles Drive
- 3 FOR the purpose of renaming Arena Drive in Prince George's County to "Bishop
- 4 James R. Peebles Drive".
- 5 WHEREAS, In 1964, the Reverend James R. Peebles, Sr. and his wife Betty
- 6 founded a Baptist mission named "Jericho Ministries" in the Odd Fellows Hall in
- 7 Washington, D.C., with a membership of six people; and
- 8 WHEREAS, Jericho Ministries constructed its first church on Douglas Street in
- 9 Washington, D.C. at a cost of \$31,000 in 1969; and
- WHEREAS, In 1977, after the Jericho Ministries grew too large for its first
- 11 church, a new 800 seat auditorium was purchased for \$1.3 million; and
- 12 WHEREAS, Jericho Ministries opened the Jericho Christian Training Center
- 13 College in 1978 which has provided a tuition-free 4-year curriculum to over 7,000
- 14 graduates in the past 20 years; and
- WHEREAS, In 1988, Jericho Ministries opened the Jericho City of Praise, which
- 16 is a \$4.5 million complex on more than 80 acres of land in Landover, Maryland; and
- 17 WHEREAS, The Jericho City of Praise is equipped with a sanctuary building
- 18 which seats 10,000 people, an educational building with an 800 student capacity, and
- 19 a college building with a 3,000 student capacity; and
- WHEREAS, The Reverend Peebles was ordained as Bishop of the Jericho
- 21 Ministries in 1988; and
- WHEREAS, Bishop Peebles and his Jericho Ministries have provided clothing,
- 23 food, and shelter to thousands of people in need; and
- 24 WHEREAS, Jericho Ministries has provided convalescent home ministry,
- 25 ministry for the incarcerated, Spanish outreach ministry, and hospital "cheer-up"
- 26 ministry; and
- 27 WHEREAS, Bishop James R. Peebles died in 1996, leaving a church he built
- 28 with over 8,000 members; now, therefore, be it

- 1 RESOLVED BY THE GENERAL ASSEMBLY OF MARYLAND, That Arena
- 2 Drive in the Landover area of Prince George's County be renamed "Bishop James R.
- 3 Peebles Drive"; and be it further
- 4 RESOLVED, That a copy of this Resolution be forwarded by the Department of
- 5 Legislative Services to the Honorable Parris N. Glendening, Governor of Maryland;
- 6 the Honorable Thomas V. Mike Miller, Jr., President of the Senate of Maryland; and
- 7 the Honorable Casper R. Taylor, Jr., Speaker of the House of Delegates.
