## FISCAL NOTE

House Bill 691 (Delegate Proctor) Commerce and Government Matters

#### School Buses - Display of Telephone Number for Reports of Unsafe Driving Practices

This bill authorizes a local board of education to require school buses operated within its jurisdiction to display a telephone number so that a motorist can report any unsafe driving practices of the school bus operator. If so required, local boards must: (1) designate a public agency, private contractor, or other person to receive, record, and investigate reports of unsafe driving practices; and (2) specify personnel, disciplinary, or law enforcement actions that may be taken against a school bus operator who is a subject to an unsafe driving report.

### **Fiscal Summary**

State Effect: None.

**Local Effect:** Indeterminate. Local expenditures could increase to the extent that local boards require the display of telephone numbers on school buses.

Small Business Effect: Minimal.

## **Fiscal Analysis**

**Local Effect:** Approximately 6,000 school vehicles are used to transport public school students in Maryland, of which 50% are publicly owned and 50% are operated by private contractors. The cost to display a telephone number on a school bus is estimated at \$50 per school bus. Assuming all local boards of education implement this requirement, local expenditures could increase by \$150,100. The actual impact would depend upon whether the local school system requires the display of telephone numbers on school buses and the number of school buses that are publicly owned. Around 90% (\$132,700) of potential local expenditures would occur in four jurisdictions (Baltimore, Frederick, Montgomery, and Prince George's counties) that have the most publicly owned school buses if all local boards of

education implement the requirement.

In addition, designating a private contractor to record and investigate reports of unsafe

driving practices of school bus operators could increase local expenditures by around \$100,000 annually. This is based on an estimated cost of \$16 per vehicle, which is the current cost for this service in Prince George's County. However, if existing school staff record and investigate these reports, local expenditures would not be affected.

**Small Business Effect:** Private contractors operate 50% (2,956) of school vehicles used by public schools in Maryland. A large segment of these school vehicles are either owned or operated by individuals or by small companies. If all of these school buses were required to display telephone numbers, costs for private contractors could total approximately \$147,800 which is equivalent to \$50 per bus.
