Senate Bill 596 (Senator Hoffman. et al.)

Budget and Taxation

Higher Education - Funding

This bill states that it is the intent of the General Assembly that, barring unforeseen economic conditions, the Governor shall include in the annual budget for fiscal 2000 and each year thereafter an amount of general fund support for "higher education" equal to or greater than the amount appropriated in the prior year. The bill also states that it is the goal of the State that annual general fund and capital support for higher education amount to no less than the following percentages of total general fund State revenues:

- ° 12.5% in fiscal 2000;
- ° 13.5% in fiscal 2001;
- ° 14.5% in fiscal 2002;
- ° 15% in fiscal 2003; and
- ° 15.5% in fiscal 2004.

The bill also sets forth goals for the various components of the higher education operating budget for fiscal 2000 through fiscal 2002.

Fiscal Summary

State Effect: General fund and capital expenditures for higher education would not need to increase over the amounts forecast for FY 2000 or FY 2001. However, general fund expenditures for higher education would need to increase by \$50.8 million in FY 2002 to meet the goals of the bill. Out-years reflect differentials between forecasted expenditures for higher education based upon current law and policy and projected expenditures for higher education based upon the percentage goals set forth in the bill. No direct effect on revenues.

Fiscal Analysis

State Expenditures: Attachment 1 compares forecasted general fund and capital expenditures for higher education based upon current law and policy with projected general fund and capital expenditures for higher education based upon the percentage goals set forth in this bill, for fiscal 1999 through fiscal 2004. As is shown, total general fund expenditures for higher education are forecasted to be greater each year than the year before. Therefore, the bill's statement of intent that the Governor allocate for higher education at least as much money as the year before should be attained within the normal course of events. Likewise, the bill's goals that higher education funding amount to at least 12.5% of general fund revenues in fiscal 2000 and 13.5% of general fund revenues in fiscal 2001 should also be attained in due course. However, forecasted higher education funding falls increasingly short of the bill's percentage goals for fiscal 2002 through fiscal 2004. General fund expenditures must increase by \$50.8 million over forecast in fiscal 2002 to attain the bill's goals; \$70.5 million in fiscal 2003; and \$129.3 million in fiscal 2004.
