On page 1, strike beginning with the second "of" in line 4 down through "parent" in line 5 and substitute "<u>who has committed certain crimes or acts</u>"; in line 6, after "death" insert "<u>of a child</u> <u>of the parent under certain circumstances</u>"; strike beginning with the first "of" in line 6 down through "parent" in line 7 and substitute "<u>who has committed certain crimes or acts</u>"; in line 7, after "child" insert "<u>under certain circumstances</u>"; strike beginning with the first "the" in line 7 after "child" insert "<u>under certain circumstances</u>"; strike beginning with the first "the" in line 9 down through the first "from" in line 10 and substitute "<u>a prohibition against a parent who commits certain crimes or acts</u>"; and in line 11, after "distribution" insert "<u>under certain circumstances</u>".

#### AMENDMENT NO. 2

On page 1, in line 26, after "(a)" insert "(1)"; and after line 27, insert:

## "(2) A PARENT MAY NOT BE A BENEFICIARY IN A WRONGFUL DEATH ACTION FOR THE DEATH OF A CHILD OF THE PARENT IF:

(I) 1. THE PARENT IS CONVICTED UNDER ARTICLE 27, § 35C, § 335, § 462, § 463, § 464, § 464A, § 464B, OR § 464C OF THE CODE; OR

<u>2. THE PARENT COMMITTED AN ACT PROHIBITED UNDER</u> ARTICLE 27, § 35C, § 335, § 462, § 463, § 464, § 464A, § 464B, OR § 464C OF THE CODE;

## (II) THE OTHER PARENT OF THE CHILD IS THE VICTIM OF THE CRIME OR ACT DESCRIBED UNDER ITEM (I) OF THIS PARAGRAPH; AND

(III) THE OTHER PARENT OF THE CHILD IS A CHILD OF THE PARENT.".

#### AMENDMENT NO. 3

On page 3, strike in their entirety lines 15 through 17, inclusive; and strike in their entirety lines 20 through 22, inclusive, and substitute:

## "<u>A SURVIVING PARENT IS NOT ENTITLED UNDER § 3-104 OF THIS SUBTITLE TO</u> A DISTRIBUTION OF THE NET ESTATE OF A CHILD OF THE PARENT IF:

# (1) (I) THE PARENT IS CONVICTED UNDER ARTICLE 27, § 35C, § 335, § 462, § 463, § 464, § 464A, § 464B, OR § 464C OF THE CODE; OR

(II) THE PARENT COMMITTED ANY ACT PROHIBITED UNDER ARTICLE 27, § 35C, § 335, § 462, § 463, § 464, § 464A, § 464B, OR § 464C OF THE CODE;

## (2) THE OTHER PARENT OF THE CHILD IS THE VICTIM OF THE CRIME OR ACT DESCRIBED UNDER ITEM (1) OF THIS SUBSECTION; AND

### (3) THE OTHER PARENT OF THE CHILD IS A CHILD OF THE PARENT.".
